██████████ called me on June 7, 1976 (the dates in my first letter were wrong) and explained that he was aware of sexual advances made by Mark Bulshey to his son, ██████████. I made arrangements to meet with them on June 8th.

██████████ explained that Mark had talked with her about ██████████ becoming the S.P.L. about 3 months ago. Since that time, he has called very frequently and talked for long periods. She felt that this was strange. She explained that two months ago, the troop changed its meeting place from the American Legion Post to a barn at 681 E. Main Street Ext.

██████████ then told me that Mark would occasionally grab his genitals while they were fixing up the barn. Mark, ██████████ and ██████████ did most of the work. The three boys are patrol leaders. ██████████ was not sure if Mark ever did the same to the other boys while they were working.

The troop went camping Memorial Weekend, May 28-31. Since ██████████ was ██████████, he was allowed to sleep in Mark's camper trailer. No other adults were along. ██████████ said that Mark wanted to give him a rub down. While he was doing this, he tried to get in ██████████ bunk with his sleeping bag. Finally, ██████████ gave in and let Mark pull down his underwear and masturbate him even though he had protested. Mark wanted ██████████ to do the same to him, but he refused. This was the end of the incident.

██████████ said that the next day he told ██████████ that he wouldn't sleep in Mark's trailer any longer. ██████████ said that possibly ██████████ and ██████████ had been involved with Mark, but he was not sure.

After about a week ██████████ told his mother. She and her husband called me. ██████████ feels that the ██████████ and the ██████████ were not aware of what was happening.

Mark did not threaten [redacted] not to tell anyone.

Bert Sprague, Commander of Post 175, and I talked with Mark on the 9th in the evening. Bert relieved Mark of being the Scoutmaster. Mark immediately denied everything and went to call his parents and the committee chairman, Mrs. [redacted]. I felt I should talk with another boy at this point.

I went to see [redacted] and told him the problem. He called in his son, [redacted] and we talked with him. I asked [redacted] to tell me about Mark and anything unusual that might have happened between him and Mark. I reworded this several times, but finally had to explain what homosexuality was. He finally understood and told me that Mark often grabbed his genitals and those of other boys while on campouts. He said Mark made jokes about "your ding-a-ling, my ding-a-ling".

Nothing happened to [redacted] while they were all working on the barn. He did remember [redacted] telling him that he did not want to sleep in Mark's trailer again. [redacted] also said that Mark would grab the boys' breasts occasionally.

[redacted] had worried about Mark acting funny while they were working on the barn. I asked [redacted] and he mentioned he thought that Mark's temper had caused most of the Scouts to leave the troop. The troop has lost thirteen Scouts in the last month. I asked [redacted] earlier about this and he felt they had not left because of sexual advances made by Mark.

[redacted] then told me that during the Memorial weekend campout they had collected toads. While [redacted] (slightly retarded according to [redacted]) was in the bathroom, they put them in his sleeping bag at Mark's urging. All the boys were sent to their tents and told to sing and make noise so that [redacted] would not hear the toads until he returned. When [redacted] returned, he got undressed and got in his sleeping bag. He began laughing at the toads and Mark began placing them in his undershirt and underpants.

Mark called while I was at the [redacted] [redacted] would not let him talk to [redacted] [redacted] a Scout, called next, but I'm not sure why. Finally, Mrs. [redacted] called. I was talking with her when Mark's father got on the line. I explained to him what I had done in talking with the Scouts. He wanted to know what was said, but I felt it was only Mark's business. He said Mark wanted them to know. I then called Bob Wood and relayed all the information to him. It was felt a meeting with the head of the sponsor, the chairman, Mark's parents, Mark and myself was necessary.



I saw Bert Sprague the same evening and we set up the meeting for 10:00 p.m. the same evening. I explained the whole story to everyone. Mark denied everything but the toad incident. Bert told Mark he was no longer Scoutmaster, and that if he wished to pursue it any further, he would have to take the initiative.

We have not heard from Mark after this last meeting as to any other cause of action. There is some question as to which nights these incidents occurred and how many nights [REDACTED] slept in Mark's trailer. The stories by the two boys do collaborate somewhat, so I feel the placing of Mark's name in the confidential file is necessary.

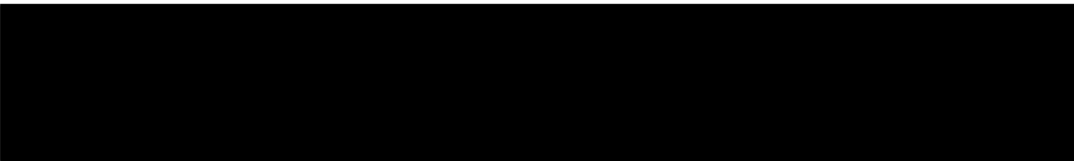

Dear Paul,

I would like to recommend that Mark T. Bulshey, 37 Fuller Street, North Adams, Mass. be placed in the confidential file. Mark is 21 years old, an Eagle Scout, and works for Sprague Electric in North Adams.

[REDACTED] contacted me on June 8, 1976, then in talking with their son, [REDACTED] on June 9th, he told me that Mark had sexually molested him while on a troop weekend campout May 28-31. He also said that Mark had made gestures and sexual contacts at other times.

I contacted another family - [REDACTED] their son [REDACTED] is friends with [REDACTED] and according to [REDACTED] would also have knowledge of this.

[REDACTED] with his father present, said that [REDACTED] came to him Saturday, May 29th and refused to sleep in Mark's trailer anymore. [REDACTED] did not know what had happened, but in further discussion said that Mark, on several occasions, made sexual contacts with him and other Scouts.

This along with several other incidents that happened that weekend, prompted Bert Sprague, Commander of the American Legion Post 125, sponsor of Troop 125, to relieve Mark of any authority with the Troop. He also instructed him not to have anything to do with the Troop in the future.

The committee chairperson and Mark's parents are aware of this situation at Mark's choosing. Mark has denied all this, but to date has taken no action on the accusations.
