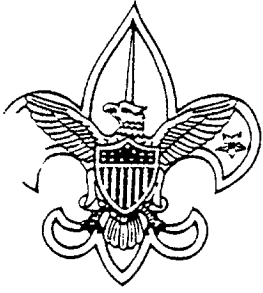



18 and dignity of the State of Washington.

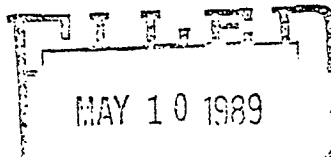

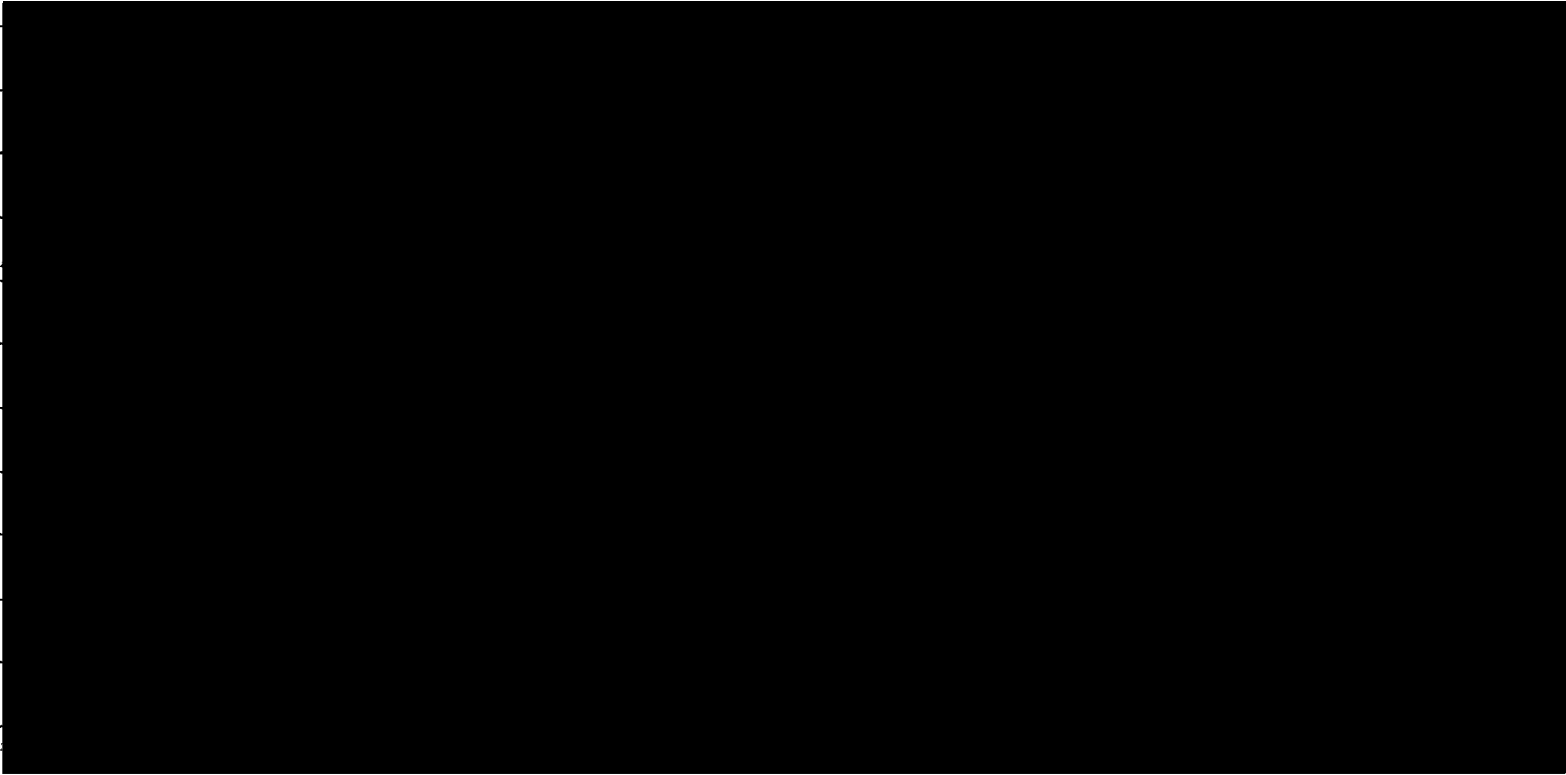
