Our District Executive received a phone call from [REDACTED] Committee Member of Troop 311 stating that Martin Skelly, Assistant Scoutmaster of Troop 311 had bragged that he had a record of child abuse and theft. [REDACTED] wants to remain anonymous because she is frightened of Mr. Skelly. One of our Scouters with the Sheriff's Department checked and found out that Mr. Skelly was convicted in 1982 of misdemeanor child abuse and sentenced to 60 days (50 days suspended). On Mr. Skelly's application he stated that he has never been charged with child neglect and has never been convicted of a criminal offense. Attached are copies of his application and a statement by Bill Oswald, District Executive.
