Assault nets jail sentence for trooper

A former Washington State Patrol trooper accused of molesting a teenager in a ride-along program was sentenced Tuesday to serve nine months in jail.

Pierce County Superior Court Judge Nile Aubrey ordered the jail time, despite a prosecutor's recommendation that former trooper Marty V. Dreher serve no time behind bars at all.

Stressing that Dreher was placed in a special position of trust as a patrol officer, Aubrey said: "What you did is far, far more serious than someone not clothed with the authority you were."

Prosecutors contended Dreher twice had sexual contact with a 16-year-old girl assigned to ride in his patrol car under a program chartered by the State Patrol. The University Place man was accused of intimidating the teenager into performing oral sex when she went

for a ride with him in August 1987, and into having sex with him at her house two months later.

Dreher, 36, pleaded guilty to the gross misdemeanor of simple assault after prosecutors agreed to dismiss two counts of communicating with a minor for immoral purposes. Dreher, however, entered what is known as a "Newton plea," in which he maintained his innocence but said he wanted to take advantage of a plea bargain. He contended the acts were consensual.

Despite letters from family and friends attesting to Dreher's good character, the judge ordered Dreher to serve nine months in jail, pay a \$365 fine and restitution to the girl, who wants reimbursement for counseling. He specified the sentence be deferred, meaning Dreher eventually could have the charge removed from his record if he follows the conditions.

Dreher's attorney, Sverre Staurset, said he would appeal the case.

Sex charges against trooper

A former state trooper, accused of molesting a teenage girl participating in a ride-along program has pleaded guilty to simple assault.

Marty V. Dreher said he didn't believe he touched the teenager in a harmful or uninvited manner, but was pleading guilty to take advantage of a plea bargain, according to Pierce County Superior Court papers.

"He's adamant he did nothing wrong," his attorney, Sverre Staurset, said. "I agree, but it's a risk management thing."

The defense was unwilling to risk going to trial and a possible conviction in light of the prosecutor's offer to ultimately have the charge erased from Dreher's record, he said.

The agreement calls for prosecutors to dismiss two additional counts of communicating with a minor for immoral purposes, Deputy Prosecutor Mike Riggio said. All three charges were gross misdemeanors carrying a maximum penalty of one year in jail and a fine.

Dreher entered the plea Monday before Pierce County Superior Court Judge Nile Aubrey.

At sentencing, the prosecution will recommend the 36-year-old Tacoma man receive a deferred sentence on condition he perform 240 hours of community service and serve one year probation, court papers said. Prosecutors also will suggest he pay restitution to the victim and \$513 in fines and court costs. If he successfully completes the conditions, the charge would be expunged from his record after one year.

Dreher, however, objected to paying for the teenag-

er's restitution. He argued it would be impossible to tell whether the girl's problems stem from her sexual contact with him or the years of sexual abuse she suffered before she ever met him. Prosecutors said the girl was the victim of long-term sexual abuse before she had contact with Dreher.

The plea bargain was reached after Staurset sought to have the two communication charges dismissed, arguing they would not have survived a constitutional attack. Riggio added that the main goal in the case was to keep the victim from having to undergo the trauma of testifying at trial.

The first incidence of sexual contact happened in August 1987, when the then-16-year-old girl was partici-

pating in a ride-along group chartered by the State Patrol, according to court records. Dreher was accused of intimidating the teenager into performing oral sex when she went for a ride in Dreher's patrol car. Prosecutors alleged that two months later, Dreher, while wearing his uniform, once again intimidated the girl into having sex at her house.

Dreher resigned the day after charges were filed in July. The state patrol says he resigned on his own. He said patrol officials pressured him into resigning, instead of allowing him to try to keep his job through the patrol's appeal process.

"In essence he was fired for indiscretion, not because he did something illegal," Staurset said.

dered to turn in his uniform, gun, badge and car, and stay home, with pay, pending an internal investigation.

When the case appeared to involve criminal misconduct, the Patrol suspended its internal investigation and handed the case over to the Pierce County sheriff's office for criminal investigation, Burkett said.

Dreher initially denied the allegations, but he later confirmed the girl's statements, Corey-Boulet wrote in the charging papers.

Burkett described Dreher's career with the Patrol as ordinary — neither marked by problems nor distinctions of merit. The Patrol knows of no previous criminal charges against Dreher.

Had the officer not resigned, the Patrol would have resumed its internal investigation, then waited until the criminal case was resolved before deciding whether to take disciplinary action, Burkett said. Sexual misconduct, or any other violation of state law, could be a basis for dismissal.

"In general, the (state trooper) rules state the very first duty of someone charged with enforcing laws is to obey the law," he said. "That covers everything from littering to the grimmer types of things."

Trooper quits after charges he molested girl in car

A state trooper resigned Thursday in the wake of charges he twice molested a teenage girl, including once in his patrol car as he took her for a ride under a program sponsored by the State Patrol.

Marty V. Dreher, 36, was charged Wednesday in Pierce County Superior Court with two counts of communicating with a minor for immoral purposes and one count of simple assault. The charges are gross misdemeanors, carrying the possibility of one year in jail and a fine.

The officer submitted a two-line statement of resignation Thursday without explaining his reasons for the decision, said Patrol spokesman Bill Burkett. The resignation was accepted.

Thursday was Dreher's eight-year anniversary as a state trooper, Burkett said.

Neither Dreher, who has an unlisted phone number, nor his attorney, David Graves, could be reached for comment Thursday. Dreher, who was assigned to work in the Tacoma district, was required to live in Pierce County, Burkett said.

He is scheduled to appear in court to answer the charges July 19.

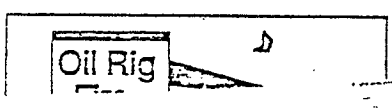
The case marks the first time in the State Patrol's 67-year history that a trooper has been charged with sexual misconduct on or off duty, Burkett said.

"This is not pleasant," he said. "The real concern of everybody is that this victim be protected at all costs."

That victim is a 16-year-old girl who was sexually abused as a child, county prosecutor Barbara Corey-Boulet said in charging papers. The teenager belonged to one of several riding groups chartered by the State Patrol. The groups give young people a chance to experience the law enforcement field by riding along with patrol officers or watching communication officers work, Burkett explained.

In August, as part of her group's activities, the teenager was assigned to ride with Dreher. Corey-Boulet wrote in an affidavit accompanying the charges. During the night ride, the officer pulled off a Gig Harbor Bay

State trooper facing 2 sex charges resigns

TACOMA - A state trooper resigned yesterday morning, after being charged Wednesday in Pierce County Superior Court with simple assault of a 15-year-old girl and communicating with her for immoral purposes.

Trooper Marty V. Dreher, 36, who completed eight years with the patrol yesterday, will plead innocent when he is arraigned July 25, said his attorney, Daryl Graves.

"It is extremely unfortunate," Graves said of the charges, which caused Dreher to quit his job at 9 a.m. Dreher is married and has children.

Dreher was removed from duty and placed on administrative leave a month ago, state patrol spokesman Bill Burkett confirmed yesterday.

Dreher was assigned to the Tacoma headquarters two years ago after working in Spokane, the patrol said.

Two incidents of immoral communication allegedly occurred in August and October in Dreher's car and at the girl's house, said an affidavit accompanying the charges. In one incident, the affidavit said, the girl was physically assaulted.

Dreher was on duty, in a marked car, and in uniform at the time, said Burkett. The affidavit said Dreher failed a polygraph test while the girl passed one.
