
Enclosed is a copy of a letter that we delivered to Matthew Barnes, who is registered as an ASM in Troop 77 in our council.

I was advised by Peter Vasquez (another ASM in that unit), who is an officer with the Los Angeles County Sheriff's Department, that Matt is "under investigation" for possible child abuse. He has also displayed behavior in Scouting activity that is not acceptable for a Scout leader. The leaders of Troop 77 had suspended him from the Troop.

Our information is that he has no known address - is a "street person" - and that his mother "kicked him out of her house."

If I get more information, I'll send it along.

At the request of A. S. Peter Vasquez and A. S. James Talbot of Troop 77, chartered to St. Elizabeth Church in Pasadena, the registration/membership of Mathew Barnes was suspended pending investigation into various allegations.

On various occasions, Matt has used much foul language, boasts of his arrest record for carrying concealed weapons (brass knuckles and oversized knives), rough horseplay with the Scouts and put himself in inappropriate positions between other leaders and the Scout of Troop 77. On a backpacking trip the weekend of July 16-17, 1988, Matt was insistent on sharing a tent with 2 Scouts. In the morning, one Scout revealed that Matt had given "massages" and had led an unauthorized midnight "skinny-dipping" raid on the adjacent river. All Troop leaders agree that Matt continually befriends the Scouts and takes their sides in decisions made by other leaders.
