Below is an update on the ineligible record files of Matthew D. C. Vincent and Theodore McArthur.

Mr. Vincent pleaded guilty last week to sexual assault and received a twenty year sentence.

Mr. McArthur was charged with attempted sexual assault on a child and sentenced to four years at the community corrections institution in Arapahoe County, ordered to pay restitution and is currently attending sex therapy. However at this time there is no bed space available, and he is waiting to be transferred. In the meantime, he is in a work release program at the Elbert county jail.

Mr. Vincent is out on bail and a trial will be held in January or February on one charge. Other charges from 1986 are still pending. I'll keep you posted on the outcome of the trial.

In regards to the case of Mr. McArthur, the victim's family has decided not to pursue any legal action at this time. Since the alleged incident occurred in Canada and our Department of Social Services has indicated they will not pursue the allegation because it is out of their jurisdiction, I believe the file can now be closed.
