

NATURE OF HEARING

REPORT AND PRONOUNCEMENT OF JUDGMENT

Dep. Prob. Off: Bob Winters

Case regularly called for hearing. Defendant is present in person.

IT IS ORDERED that hearing set for 10/12/89 is advanced to this date and time.

Court has received, read and considered the Report of the Probation Officer and same is made a part of the record.

Counsel waive formal arraignment for sentencing.

No legal cause appearing why judgment should not be pronounced, the Court pronounced judgment as follows:

~~Defendant having been convicted by his plea of guilty to the crime of violation of §288(c) P.C., commit a lewd and lascivious act upon a child under 14 years, a felony.~~

IT IS ORDERED, ADJUDGED AND DECREED that pronouncement of judgment be suspended and the defendant admitted to probation for five years on the terms and conditions of probation in the written order, including: pay a restitution fine of \$100 at the rate of \$10 per month, pay a fine of \$100 including all assessments at the rate of \$10 per month with both payable through the Tuolumne County Central Collections commencing 30 days after release from jail, participate in counseling as directed, not be in the presence of minor children except with a responsible adult over the age of 21 present or as approved by the Probation Officer, register pursuant to §290 P.C. and serve a term in the Tuolumne County Jail of nine months with credit for actual time served of 88 days plus 44 days credited In re Sage for a total credit for time served of 132 days.

Defendant remanded to the custody of the Tuolumne County Sheriff.
