We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

COMPLAINANT [REDACTED] STATED THAT HE HAD KNOWN SUSPECT BAILEY FOR APPROXIMATELY 2 YEARS BEFORE THE ASSAULT. COMPLAINANT [REDACTED] HAD GONE TO SUSPECT BAILEY'S HOUSE BEFORE THEY LEFT ON A CAMPING TRIP. WHILE AT THE HOUSE COMPLAINANT [REDACTED] OBSERVED TWO STACKS OF PORN MAGAZINE AND STARTED TO LOOK AT ONE. WHILE LOOKING AT HE MAGAZINE COMPLAINANT [REDACTED] BEGAN TO GIGGLE. SUSPECT BAILEY ASKED COMPLAINANT [REDACTED] WHAT WAS SO FUNNY AND HE SAID THAT HE HAD JUST THROUGH OF A FUNNY VARIATION OF BACK GAMMON CALL STRIP BACK GAMMON. AFTER HEARING THIS SUSPECT BAILEY ASKED COMPLAINANT [REDACTED] IF HE WANTED TO TRY A GAME. DURING THIS GAME COMPLAINANT [REDACTED] WAS AT THE POINT OF BEING COMPLETELY NAKED WHEN SUSPECT BAILEY LOOKED AT HIS WATCH AND TOLD COMPLAINANT [REDACTED] HE SHOULD GET HIM HOME. SUSPECT BAILEY TOOK COMPLAINANT HOME AND ASKED HIS MOTHER IF THEY COULD RETURN TO HIS HOUSE TO FINISH A GAME THEY HAD STARTED BEFORE THEY LEFT ON THEIR CAMPING TRIP. WHEN COMPLAINANT [REDACTED] MOTHER AGREED THEY RETURNED TO SUSPECT BAILEY'S HOUSE. SUSPECT BAILEY HAS COMPLAINANT [REDACTED] STRIP COMPLETELY NAKED AGAIN AND THEY CONTINUED THE GAME. WHEN SUSPECT BAILEY WON ANOTHER MOVE HE ASKED COMPLAINANT [REDACTED] WHAT THEY SHOULD DO NOW. WHEN COMPLAINANT [REDACTED] DID NOT ANSWER SUSPECT BAILEY STARTED TO FONDLE COMPLAINANT [REDACTED] GENITALS. SUSPECT BAILEY THEN STARTED TO MASTURBATE WITH COMPLAINANT [REDACTED] GENITALS FOR ABOUT A MINUTE. SUSPECT BAILEY THEN QUITE REMOVED HIS CLOTHES THEN HAD COMPLAINANT [REDACTED] START TO MASTURBATE WITH SUSPECT BAILEY'S GENITALS. AFTER ABOUT A MINUTE SUSPECT BAILEY HAD COMPLAINANT [REDACTED] STOP AND THEN SUSPECT BAILEY HAD COMPLAINANT [REDACTED] TO LAY DOWN ON HIS BACK. SUSPECT BAILEY THEN STARTED TO HAVE ORAL SEX WITH COMPLAINANT [REDACTED]. WHAT WENT ON HERE NEVER HAS TO HAPPEN AGAIN". SUSPECT BAILEY THEN TOOK COMPLAINANT HOME. COMPLAINANT DID NOT REVEAL THE ASSAULT FOR SEVERAL MONTHS UNTILE HE FINALLY TOLD HIS MOTHER, WITNESS ABOUT IT, APPROXIMATELY 1 MONTH AGO. WITNESS WAS NOT GOING TO DO ANY THING ABOUT THE ASSAULT, UNTIL SHE DECIDED TO CALL CONTACT, WHO REFERED HER TO THE FAMILY SERVICES, AT 4343 MAPLE AVENUE. COMPLAINANT [REDACTED] STATED TO REPORTING OFFICER BASSINGER THAT SUSPECT BAILEY HAD ASSAULTED HIM APPROXIMATELY 10 TO 20 TIMES OVER THE PERIOD OF APRIL THROUGH JUNE OF THIS YEAR. COMPLAINANT [REDACTED] STATED THAT THE ASSAULTS WOULD BEGIN WITH GAMES OF STRIP BACK GAMMON AND GAME OF STRIP POLKER. AS TIME WENT ON THE GAMES STOPPED AND SUSPECT BAILEY WOULD JUST HAVE COMPLAINANT [REDACTED] REMOVE HIS CLOTHES AND THEY WOULD PERFORM THE SEX ACTS. LATER COMPLAINANT [REDACTED] REFUSED TO REMOVE HIS CLOTHES AND HE WOULD MAKE SUSPECT BAILEY TAKE THEM OFF IN ORDER TO PERFORM THE SEXUAL ACTIVITY. THEN TOWARD THE END OF JUNE COMPLAINANT [REDACTED] REFUSED TO GO ANY WHERE OR DO ANYTHING WITH SUSPECT BAILEY. COMPLAINANT [REDACTED] STATED THAT THE SEXUAL ACTIVITY, INCLUDED COMPLAINANT [REDACTED] AND SUSPECT BAILEY MASTERBATING EACH OTHER AND BOTH HAVING ORAL SEX WITH EACH OTHER. SUSPECT BAILEY TRYED TO GET COMPLAINANT [REDACTED] TO HAVE ANAL SEX WITH HIM, BUT COMPLAINANT [REDACTED] REFUSED. COMPLAINANT [REDACTED] ALSO STATED THAT SUSPECT BAILEY WAS VERY PASSIVE DURING THE SEXUAL ASSAULTS AND NEVER PHYSICAL THREATEN HIM. COMPLAINANT [REDACTED] STATED THAT SUSPECT BAILEY WOULD BELITTLE HIM AND VERBALLY INTIMIDATE HIM INTO PARTICIPATING IN THE SEXUAL ACTIVITY.
