
Dear Paul:

Complete information relative to the case of Michael Woodford resulted from the availability of Court files, case # CR00234426. Woodford was charged on 8/29/87 with a 4th Degree Sex Offense, pled guilty, was found guilty on 1/14/88 and received a suspended sentence. He is on probation for 4 years, undergoing court ordered psychiatric counseling, which can only be terminated with the permission of the court and the counselor.

Court records show that Woodford was on probation for a similar offense in the state of Virginia, at the time of this offense. There were no court records indicating any additional offenses.
