Dear Michael:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand that B.S.A. membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the B.S.A. seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a B.S.A. member should be granted or reinstated. The procedures for review are attached.

Mike Overton, Mendon, MI, was accused of sexual assault on two young children when he was sixteen years of age (he is now 18). A probation petition will be issued to him, charging him with sexual assault as a juvenile. Mike has been instructed by Det/Sgt. Robin Baker not to have anything to do with the Boy Scouts of America at this time. Mike is in the care of his mother, pending further investigation.

The accusations were brought to the attention of authorities on April 6, 1990. Det/Sgt. Baker made contact with Bud Horning, ASM-Troop 427, Mendon during the week of April 23rd pertaining to this matter and Bud related the information to [REDACTED] wife of Scoutmaster [REDACTED], Troop 427.

I really hate to bother you again, but I have written twice since receiving a phone call from your council. This call indicated that the above named individual had been accused of having sex with two younger boys. Apparently, this incidence happened a couple of years ago.

We were told that a letter would be given to this individual and that we would get a copy, and so far we have not received a copy. We would like this for our files.

We are enclosing an Ineligible Volunteer Record Sheet which we must have, so we can identify Mr. Overton should he attempt registration in some other location. Please give us as much information as available.

We would also like some statements from the parents of the youth who were abused. This would strengthen our file and help us to substantiate our refusal of registration. If there is to be legal action, we would like copies of newspaper clippings or court records.
