Hoopeston man given seven-year sentence

A Hoopeston man convicted on charges of child pornography and sexual abuse was sentenced Friday to serve seven years in prison.

Michael Hosch, 23, of 617 E. Washington St., was charged in October 1989 with five counts of aggravated criminal sexual abuse and two counts of child pornography.

Hosch was identified at the time of his arrest as an associate scoutmaster for Boy Scout Troop 138 in Vermilion County.

The 15-year-old-boy he sexually abused was not affiliated with the troop, Boy Scout spokesmen said.

Hosch abused the boy between Feb. 1, 1989, and Oct. 30, 1989, and photographed the boy while "actually engaged in the act of sexual contact," court records said.

He pleaded guilty in April to two counts of aggravated criminal sexual abuse and one count of child pornography in exchange for a maximum 10-year prison term.

The remaining charges were dismissed as part of a plea agreement.

The sexual abuse charges were Class 2 felonies. Each count was punishable by three to seven years in prison and \$10,000 in fines.

Circuit Judge Rita B. Garman said the child pornography charge was a Class 1 felony, punishable by a four- to 15-year prison term and \$20,000 to \$50,000 in fines.

Man faces sex abuse, child porn charges

A 23-year-old Hoopeston man faces trial Monday on charges of sexual abuse and child pornography, Vermilion County Circuit Court records show.

Michael James Hosch, of 617 E. Washington, remained in Vermilion County Jail today on \$75,000 bond after being charged last October with five counts of aggravated criminal sexual abuse and two counts of child pornography.

Hosch was identified at the time of his arrest as an associate Boy Scouts scout-master for Troop 138 in Vermilion County.

He's accused of sexually abusing a 15-year-old boy between Feb. 1 and Oct. 30, 1989, and photographing him while "actually engaged in the act of sexual contact." court records show.

This marks the second time in six months in Vermilion County a man involved in a scouting group has been arrested on sexual abuse charges.

Kennetn Cheney, 56, 408 W. Fairchild, a Big Brother/Big Sister volunteer and scoutmaster, was charged with sexually abusing an 8-year-old boy a week ago.

Court records identified the alleged victim as Cheney's "little brother." Cheney, according to Big Brothers/Big Sisters, has been associated with the affiliate in Danville since 1977. Cheney is scheduled for a court appearance at 1:15 p.m., May 3, for a preliminary hearing — to determine whether there's sufficient reason for trial.

Hoopeston man admits guilt

Ex-scout leader faces 10 years for sex abuse, pornography

A 23-year-old Hoopeston man pleaded guilty to sexual abuse and child pornography charges in exchange for a maximum 10-year prison term, court records show.

Michael James Hosch remained in Vermilion County Jail today on \$75,000 bond. He was charged last October with five counts of aggravated criminal sexual abuse and two counts of child pornography.

Hosch pleaded guilty Monday to two counts of aggravated criminal sexual abuse and one count of child pornography, said State's Attorney Craig DeArmond. The remaining charges against Hosch were dismissed in exchange for the guilty plea,

DeArmond said."

Hosch's case was turned over to court probation services for a pre-sentencing investigation and report. Upon completion of the report within the next 30 days a sentencing hearing date will be scheduled, officials said.

The sexual abuse charges were class 2 felonies, each count punishable by a three-to-seven year prison term and \$10,000 in fines, said Chief Circuit Judge Rita B. Garman. The pornography charge is a class 1 felony, Garman said, and could be punishable with a four-to-15 year prison term and a \$2,000-\$50,000 fine.

Hosch was identified at the time of his arrest as an associate Boy Scouts scoutmaster for Troop 138 in Vermilion County. He pieaded guilty to sexually

Police uncovered some "un-"!usual' items after the arrest; he said. Kaag refused to elaborate and identify those items. and the state of the state of

Hosch was arraigned on the charges in Vermilion County Circuit Court: Wednesday afternoon. Because of his financial status, the county's public defender's office was appointed to defend him.

During questioning by Associate Judge Joseph P. Skowronski, Hosch said he moved into Hoopeston only seven months ago. He formerly was a resident of Colorado Springs, Colo., he said. He also told Skowronski that he was on probation for an Indiana burglary conviction.

Edward Miller; Vermilion HOOPESTON - Hoopeston's County probation officer, was police arrested a man Monday on called by DeArmond to testify for the purposes of bond Hosch, s Miller said, was on parole following a conviction for theft by deception in Indiana. He also was on probation with parole for a burglary conviction in Spencer, Ind. That parole period would have ended July 29, 1991, Miller

Owen County Indiana authorities issued a \$20,000 warrant for Hosch's arrest because he violated the terms of his probation, Miller said. DeArmond then asked Skowronski to set bond at \$75,000.

carceration, parole .. violation, warrant for arrest and lack of community: ties, mandated a high bond, he said. Skowronski agreed and set the suggested bail. Hosch, he said, must have no contact with the Hoopeston boy he is accused of sexually abusing.

Police reports indicate that Hosch is affiliated with Hoopeston Boy Scouts. Clyde Mayer, Vermilion County Boy Scouts of America director, said Hosch was an associate scoutmaster for Troop 138. The youth and Hosch were not affiliated through the Boys Scout troop, Kaag said.

Hosch has a preliminary hearing set for 11 a.m. on Nov. 22.
