

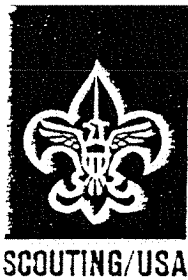

On 01/08/85 the Quincy Police Department entered into an investigation of child sexual abuse. We suspected and investigated the activities of Michael James LaRoche, white male, date of birth: 08/21/62. As you know, Mr. LaRoche was a Cub master and his activities involved a Cub Scout pack in Quincy, Illinois.

As we spoke in your office you stated that the Boy Scouts of America would document in a master file if Mr. LaRoche was convicted of a sex crime as a result of our investigation. With the hopes that this can prevent him from being affiliated with Boy Scouts of America in the future I urge you to contact the appropriate people with the following information. Mr. LaRoche was convicted of a Class 2 felony, Attempted Indecent Liberties With a Child and sentenced to four years in the Department of Corrections.

I want to take this opportunity to thank you and your office for the assistance and consideration given to the Quincy Police Department during this investigation. It is refreshing to see the same good citizenship skills exercised on an administrative level of Boy Scouts of America as is taught on the scouting level.

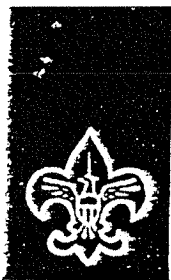



February by Ayer Police, charged with being a person under the age of 20 in possession of an alcoholic beverage and unlawful possession of a class "B" drug, to wit, cocaine, had the charges continued to April 27 for further arraignment.

Edward Lucas, also known as "Butch" Lucas, arrested by Lowell Police on Groton warrants, listing an address of 142 Jewett St., Lowell, in court on charges of receiving stolen goods and misuse of a credit card, having been found to be indigent at arraignment and ordered to produce medical records, claiming some doctors were "on vacation" had the charges continued to April 20 for a pre-trial conference and further arraignment.

Following five continuances, Donn W. Kruger, 41, of 42 Lowell Road, Pepperell, originally charged last December by Pepperell Police with indecent assault and battery on a child under the age of 14, admitting to sufficient facts was found guilty by Judge David B. Williams. The defendant was given a 2½ year House of Correction sentence, suspended with probation.

James E. Steele, of 121 Littleton Road, Ayer, charged by Ayer Police with discharging a firearm within 500 feet of a building or highway and cruelty to animal, had the counts filed without a finding, \$200 reimbursement to be paid to the town of Ayer.

James J. Jones Jr., Edgemont Ave., Billerica, summonsed to court by Groton Police, accused of operating a motor vehicle uninsured, unregistered and illegally attaching number plates, on admission had the complaints placed on file following a guilty finding, \$100 reimbursement to be paid to the town.

Leon R. Jarvis, 40 of 10 Church St., Ayer, arrested in January by Shirley police and charged with driving while under the influence of an intoxicating liquor, creating an unreasonable noise and failure to grant right of way at an intersecting way, for the third time, had the counts continued to April 19 for trial.

Steven H. Orr, 32, of Jewett St., Pepperell, originally in court last year, charged with trespassing and injury to a building lodged by Ayer police and a count of driving while intoxicated initiated by Pepperell police, on guilty plea had the charges continued to May 18 for disposition.

George A. Winters, 32, of 26 Vleckif Rd., Nashua, N.H. arrested by Pepperell police, charged with driving while under the influence of alcohol, at arraignment had the charge continued to March 30 for a pre-trial conference and further arraignment.

William P. Ronzio, 32, of Billerica, arrested by Townsend police, charged with driving while intoxicated, so as to endanger and speeding, had the counts continued to March 30 for further arraignment.

Allen F. Chandler, 24, of 35 Bolton St., Concord, arrested by Ayer police charged with illegal possession of marijuana, on admission, had the charge filed without a finding, \$25 reimbursement to be paid to the town of Ayer.

Leo R. McClellan, Jr., 26, of Townsend St., Pepperell, arrested by Pepperell police, charged with driving while intoxicated, so as to endanger, after suspension of his license and using a motor vehicle without authority, at arraignment was granted a continuance to March 30 for further arraignment.

Another defendant, Mark D. Sheehan, 20, assigned to the 104th Transportation Company, Fort Devens, declared indigent and appointed a court public defender, arrested last February by Ayer police, was found guilty on one count of assault and battery by means of a dangerous weapon and one of assault and battery on a police officer, given two six months sentences to the Billerica House of Correction, suspended with probation for one year, to be served concurrently, plus ordered to make restitution in the sum of \$800. Two other counts of assault and battery on a police officer were dismissed at the request of the Commonwealth and with the defendant's consent. Guilty and placed on file were charges of being a disorderly person and being a disturber of the peace.

Christopher G. Legros, 24, of Greenvale Ave., Weymouth, summonsed to court by Dunstable Police Chief Archer M. Davis, admitting to sufficient facts, had charges of operating a motor vehicle uninsured, unregistered and illegally attaching number plates placed on file following a guilty finding, \$100 reimbursement to be paid to the town, payment suspended to June 15.

Timothy J. McPartlan, Baddacook Pond Road, Groton, in court on a charge of driving after revocation of his license lodged by Groton police, on guilty plea was fined \$65.

Donn W. Kruger, 30 of 42 Lowell St., Pepperell, arrested in December by Pepperell police, charged with indecent assault and battery on a child under the age of 14, on plea of his attorney who told the court another counsel has been retained to act as co-defense, had the charge continued for the fifth time to March 23 for possible disposition.

Mark A. Dixon, of 3 Haskell St., Shirley, arrested by Ayer police, charged with two counts of assault by means of a dangerous weapon, had the complaints continued to March 23 for further arraignment.

Don't let your child be next. Ask yourself these questions. We tell our children to be careful of strangers, but how many of us warn them about friends and relatives? We didn't! Are you sure when your daughter spends the night with a girl friend, your son goes on his scout overnight camp, or you drop them off at the baby sitters: with teenagers, that they're safe from the hands of molesters? Donn W. Kruger, 30, of 42 Lowell Road, Pepperell, arrested by Pepperell police last December charged with indecent assault and battery on a child under the age of 14, by agreement was granted a fourth continuance to March 18 for further court action.

William Lenney, 24, of 34 Cambridge St., Ayer, in court on civilian complaints of wilful and malicious injury and annoying telephone calls, at the request of the complainant and with the defendant's consent, had the charges dismissed. Judge David B. Williams in words to the affect, the court is no place to make frivolous complaints assessed costs of \$20 to the complainant and also to the defendant.

Raymond G. Brooks, of Half St., Dunstable, in court on civilian complaint of larceny by check lodged through Groton police, failed to appear for arraignment. Defaulted, a warrant was issued for his arrest.

COURT DOCKET

William E. Burns, also known as William E. Harrison, originally in court on Jan. 12, at that time listing 201 Middlesex St., Lowell, now giving an address of Fifth Ave., Lowell, charged by Groton police with breaking and entering in the daytime and stealing in a building, was ordered in default when he failed to answer when his name was called. His court appointed attorney was unable to inform the court why the defendant was not present. A warrant was issued for the defendant's arrest.

Donald J. LaCroix, 30, of Main St., Townsend, originally in court last August 25, charged by Shirley police with a variety of criminal complaints was in court for disposition of one count of illegal possession of a class "B" drug, with intent to distribute, amended in open court to simple possession....The count had been listed as a probable cause hearing, and on change of plea from "not guilty", to "guilty", LaCroix was given a six months sentence to the Billerica House of Correction, suspended with probation for one year, \$600 seized by police confiscated as well as the contraband. The court was told a car seized at time of his apprehension had previously been confiscated, subject to a bank loan. The defendant's counsel informed the court he would later file a motion to revise and revoke within the 60 day period, not to be used for one year and ruled by Judge Rowe his guilty finding cannot be altered on such motion; the guilty finding to remain.

Mark W. Maki, of Musket Drive, Lunenburg, arrested by Shirley police last November and charged with driving while intoxicated, after suspension of his license and having defective equipment, on plea of his attorney, was granted a third continuance to March 18 for trial.

FEBRUARY 16, 1983

Donn W. Kruger, 30, of 42 Lowell Road, Pepperell, in court last December on a complaint of indecent assault and battery on a child under the age of 14 lodged through Pepperell police, by agreement of the Commonwealth and defense counsel, had the charge continued for the third time to March 2 for further court consideration.

Robert F. Dewey Jr., 27, of Acam Trailer Park, Route 2A,

North Shirley, arrested last month by Littleton police, charged with operating a motor vehicle while under the influence of an alcoholic beverage and failure to keep to the right, having previously told the court he was to be represented by a local attorney, the latter not formally having been retained, had the charges continued to March 2 for further arraignment and possible disposition.

George D. Kungulus, 50, of 159 Broadway St., Lowell, arrested last month by Dunstable police charge with driving while under the influence of an alcoholic beverage, on admission of sufficient facts, had the complaint continued without a finding for one year, \$500 in reimbursement to be paid to the town of Dunstable. Guilty of failure to keep to the right, the court levied a \$5 fine.

Vincent J. Ferrara, also known as Vincent Farraro, and Anthony Manfredini, 42, listing 15 Maimeth St., Hooksett, N.H. as address arrested by Shirley police and charged with fraudulently obtaining a controlled substance, on admission of sufficient facts was given a two months sentence to the Billerica House of Correction suspended with probation for one year. Similar counts lodged by Groton, Ayer and Townsend police resulted in the counts being placed on file following a guilty finding.

Raymond A. J. Oliver, 24, of Main St., Shirley, in court on a count of being lewd, wanton and lascivious in speech or behaviour, through counsel, admitting to sufficient facts was found guilty and placed on probation for five years.

Charles B. Conway, 23, of Tamrack Drive, Townsend, in court on a charge of larceny value less than \$100 lodged by Townsend police, on admission, had the count placed on file following a guilty finding, \$25 reimbursement to be paid to the town.

Charles T. Behler, of 16 Squannacook Road, North Shirley, in court on charges of assault and battery; attempt to murder and assault and battery by means of a dangerous weapon, lodged by Shirley police, had the complaints con-

Arrested by Shirley Police, William Lenney, 24, of 25 Cambridge St., Ayer; Thomas J. Barrows, 19 of 429 Rindge Road, James Silva, 152 Highland St., and Theron C. Taylor III, 20 of 42 Fox Street, all Fitchburg, each charged with willful and malicious injury to personal property, Taylor with a similar complaint and Lenney with making annoying telephone calls, in court before Judge Brian Rowe, had the counts continued to March 2 for dismissal, upon each defendant paying \$115 in restitution to the victim, and \$50 in reimbursement to the town, Shirley Police having initiated the complaints, following a civilian complaint.

Robert S. Cornell II, 23, of Suna Road, Townsend, originally in court last October charged by Townsend Police with receiving stolen goods, the manufacture and illegal possession of marijuana, his court appointed public defender seeking and receiving permission to withdraw from the case, the defendant was accorded a sixth continuance to Feb. 9 for appearance of his newly appointed counsel and further arraignment.

Roy Wallace, 28 of 173 West Main St., Ayer, arrested last month by Ayer Police and charged with being a disorderly person and assault and battery on a police officer, by agreement was granted a third continuance to Feb. 16 for further arraignment.

Donn W. Kruger, 30 of 42 Lowell Road, Pepperell, in court last December charged through Pepperell Police with a count of indecent assault and battery on a child under the age of 14, was granted a further continuance to Feb. 16.

Mark G. Webster, 22, member of the military assigned to duty at Fort Devens, arrested last October by Shirley Police charged with three counts of illegal possession of controlled substances including cocaine, LSD and marijuana, was granted a period extension to March 2, the court told the state analysis report has not as yet been received by the prosecution.

David J. Bolduc, 17, of 2 Spruce St., Townsend, arrested by Townsend Police and charged with illegal possession of a class "C" drug, LSD with intent to distribute at the Regional High School found guilty was fined \$1,250, given one-year to pay.

Eli Heath of 51 East Main St., Ayer, in court on two counts of larceny by check lodged through Ayer Police, on not guilty pleas was granted a carryover date for trial to March 11.

Kellie A. Marshall, of 38 Central St., Acton, arrested by Shirley Police charged with being a disorderly person, assault and battery on a police officer and injury to personal property admitting to sufficient facts had the complaints continued without a finding for a six months period, given a \$25 fine, ordered to pay reimbursement of \$75 to the town of Shirley and make restitution through the probation dept. in the amount of \$249.

Elisha Hunter, of Walker Road, Shirley, arrested in October by Shirley police and charged with driving while intoxicated, had the count continued to Jan. 25 for trial.
