

# Examination Adjourned

CORUNNA — A preliminary examination scheduled for Monday in Shiawassee County district court was adjourned for a Durand man charged with six counts of first-degree criminal sexual conduct.

A preliminary examination was rescheduled for Michael J. Martin, 25, for Aug. 25 at 1:30 p.m. Martin is being held at the Shiawassee County Jail in lieu of posting a \$250,000 cash bond.

Martin is charged with sexually abusing four boys who were less than 13 years old at the time of the alleged incidents. District Judge Bruce A. Fox originally set no bond for Martin. Martin's court-appointed attorney, Robert Ashley, later successfully argued for bond to be set.

Fox set bond at \$100,000 cash on a file containing three first-degree criminal sexual conduct charges and a \$50,000 cash bond on each of three files containing one count each of first-degree criminal sexual conduct.

Each charge against Martin carries a maximum life prison sentence upon conviction.
