Please be advised that yesterday, January 23, 1991, the Scoutmaster of Troop 616, Michael Joy, was arraigned and charged with three counts of taking indecent liberties with minors.

The facts are:

- A) The police advised us of an investigation of suspected child abuse involving Mr. Joy.
- B) Upon learning of this investigation, we immediately suspended Mr. Joy from all Scouting activity. Suspension occurred on January 14, 1991.
- C) We are and will continue to cooperate with the police as they conduct their investigation.

Be advised that key district and council volunteers have been involved in assisting and working with the leadership and parents to provide the comfort and support necessary to cope with this situation.

In addition, we have been in daily contact with our National support division which has been extremely helpful in providing the support we have needed.

If you have any questions or concerns, please contact Chuck Lang at the Scout Service Center, [REDACTED]. Be assured we will keep you advised of any future developments.



On January 7, 1991, Detective George Bloesing of the Exploited and Missing Child Unit of the Wichita Police Department shared confidential information with myself and James Rupert regarding the investigation of two allegations of child sexual abuse involving Michael R. Joy.

The names of the abused youths were not disclosed. However, according to the information provided, one of the youths was registered in Scout Troop 616 and has since transferred to another unit, and the other is a member of the YMCA.

As a result, we took appropriate action and suspended Mr. Joy from the B.S.A. We also informed the institutional head, committee chairman, and the assistant Scoutmaster of Troop 616 regarding the suspension without explanation.

As additional information is made available, I will keep you advised.
