
SUBJECT: Michael R. Spreitler


Dear Mr. Spreitler:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership and the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.

The Red Bud Police assisted the Department of Children and Family Services in the arrest of a Sparta man. As the results of an interview with Michael Spreitler, a warrant was received from the Randolph County State's Attorney for the arrest.

Spreitler was arrested July 7 and charged with aggravated criminal sexual assault which involved a juvenile.

Police said the accusations followed a family dispute.

He was taken to the Randolph County jail in Chester where bond was set at \$10,000. He was released after posting a \$1,000 cash bond.
