### Deaf-school worker charged in assault

An employee of the Texas School for the Deaf remained in City Jail on Thursday on charges of sexually assaulting a child.

Michael J. Dugan, 31, of 200 Crockett St., was arrested Wednesday at the Texas School for the Deaf, where he is employed as a house parent, police said.

Dugan is accused of sexually as-

saulting an 11-year-old boy at Dugan's residence March 19. His bond was set at \$15,000.

Sgt. Darrell Boydston of the child abuse unit said the mother of the victim learned about the assault several weeks after it occurred and reported it to the police. The boy was not a student at the school.
