



This is to put Personnel Service on notice that Scoutmaster Mike L. Barrett, 2999 Highland Dr., Smyrna, Georgia 30080, age 21 of Troop 732 has been charged with kidnapping (three counts) and Contributing to the Delinquency of a Minor" (five counts) in Newton County, Georgia as the result of an incident on July 14, 1973 at the Bert Adams Scout Reservation.

The Grand Jury on September 28, found a "True Bill" on all counts. The Superior Court will convene on October 9 for the trial.

I wanted your office to be aware of the incident in case you are contacted by other parties. Let me assure you that this office is taking every step necessary involving the incident.

Mr. Barrett has resigned as Scoutmaster and the Institutional Representative has notified this office that Troop 732 has a new Scoutmaster.

As soon as the trial is over, we will make a complete report with all details.
