We submit this letter to call your attention to an incident which involved our son, who is a member of Scout Troop 34 in Arlington Heights, Illinois. The incident took place at the 1974 Napawon Summer camp.

On the second or third night, our son slept in the tent of his scout master, Ned Harkness. During the night, he was awakened and found a hand inside his sleeping bag down at his penis. Our son said he hit the hand and it was removed. He was sleeping on a cot next to Mr. Harkness.

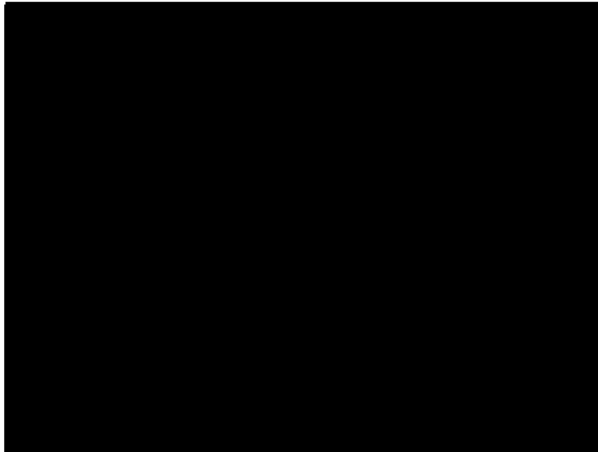
As far as we know, this was the only incident involving our son.

Dear Sir,

We feel that it is necessary to bring to your attention the following facts that we have collected, in order to insure that the safety and well being of the present and future Boy Scout members of Troop 34 not be jepordized any more than, we feel, they already have been.

1. On several campouts in the past, Mr. Harkness has requested that certain boys sleep next to him (ex: [REDACTED] 1975; Eagle Cave-Winter 1975) after these same campouts several of these boys have quit the troop citing their reason for doing so as being that during the night the scout master reached into their sleeping bags to feel their sexual organ.
2. On the 2 week trip to Shin-Go-Beek (Summer 1975) Mr. Harkness had the habit of making early morning bed checks to make sure the boys were getting up. On numerous occasions he would sit on top of a boys sleeping bag so he couldn't move then put his hand inside the scout's sleeping bag and feel around, often in places he shouldn't. Many of the older and more experienced boys got wise to this and when they heard him coming around, would run out the back of the tent. On one occasion, when the scoutmaster tried to catch a boy running out of his tent he was elboed in the stomach and the scout proceded to run away. Mr. Harkness also suggested to the boys that they sleep in their underwear or naked because "it's warmer that way."
3. At one of the weekly Boy Scout meetings in 1975 their was a game night and one of the "games" was to see how fast a

scout could take off and then put back on his clothes. Mr. Harkness became angry when several of the older boys refused to participate in this activity.

We feel that this is an outrage and we shudder to think how long this sort of thing has been going on. However, our only concern is that Mr. Harkness be immediately forced to resign his position as Scout Master and that the necessary steps be taken to insure that he is never able to lead another troop.

THIS TO INFORM THE COMMITTEE THAT I AM MAKING A FORMAL COMPLAINT AGAINST THE TROOP 34 SCOUT MASTER, NED HARKNESS. THIS MATTER RELATES TO THE CAMPOUT ~~ON~~ OCT. 31ST THRU NOV. 2ND AND CONCERNS IMPROPER BEHAVIOR BY MR. HARKNESS. MY SON RELATED WHAT HAD TRANSPIRED THE NITES OF OCT. 31ST AND NOV. 1ST. THE INCIDENTS INVOLVED THE SCOUT MASTER, AT BEDTIME, PUTTING HIS ARM INSIDE MY SON'S SLEEPING BAG. THIS DEVELOPED INTO A SITUATION IN WHICH MR. HARKNESS RUBBED ~~MY SON'S~~ LEGS, CHEST, HIPS, AND PRIVATE AREA. THE DURATION OF TIME WAS ABOUT TWO MINUTES EACH NITE. CONTACT WAS MADE ON THE OUTSIDE OF THE SHORTS AND WITH THE ~~AREA~~ ^{AREA} ON THE LEGS. MY SON SLEPT IN HIS SHORTS AND A SCHOOL SWEAT SHIRT.

THE FOLLOWING IS A STATEMENT BY MY SON

"The first nite I was excited about the camping and I really liked Mr. Harkness."

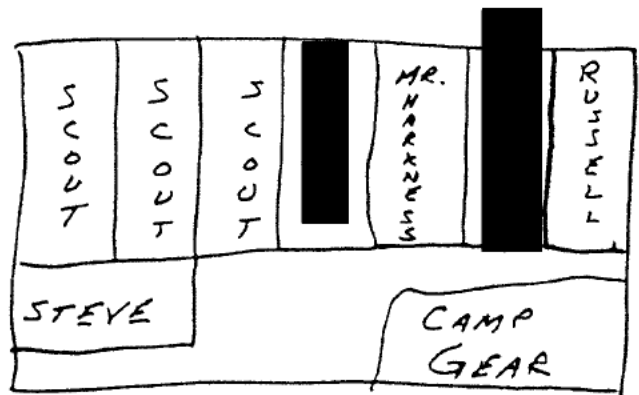

"The first night when we were in the tent we were about to go to sleep but we didn't for about an hour. When Mr. Harkness was coming to bed I wanted to talk about the Jewards with him. Most of the scouts in the tent unrolled their sleeping bags and I was talking to Mr. Harkness. I was in my sleeping bag. Mr. Harkness unrolled his bag and I right next to mine. Then he got into his sleeping bag. He scooted my bag next to his. He put his ~~left~~ left arm around my shoulder and as he talked to me he moved his hand downward. He touched my legs, privates, chest, and arm. He was holding me close to him." Then he stopped a little bit later "I did not like what Mr. Harkness did."



"The tent we were in was the large scout tent. There were six other boys besides myself in the tent. The following is how our tent was made up."

The second nite the troop and another troop played a game. The game finished and we were all very tired - we did a lot of running."

"I wanted to go to sleep but Mr. Harkness didn't want me to. He wanted me to go out and listen at the campfire. Different boys and ~~men~~ men were telling ghost stories. After the stories were over he gave us all a doughnut. Then we all bed-down. Most of the boys were asleep very soon."

"I was tired but Mr. Harkness kept me awake by talking about awards. I asked him about awards but I ~~wasn't~~ didn't expect him to talk that long." Again he scooted my sleeping bag next to his. He put his arm around me and did things like he did the nite before. He touched me in all the same places only it lasted a little longer this time." This nite Mr. Harkness layed between  and me." 

I am asking that Mr. Harkness be removed from his position as scoutmaster.

Furthermore I insist that he be excluded from any position or affiliation with troop 34.

I hope that any future ^{scouting} activities he may attempt to be associated with ~~be~~ he closely scrutinized by the proper people.
