Sentencing scheduled for Syracuse man

FARMINGTON — A Syracuse man has pleaded guilty to two counts of forcible sexual abuse in 2nd District Court and will face sentencing next month.

Norman C. Barber pleaded guilty to the charges Tuesday before Judge Rodney Page in a plea bargain with the Davis County Attorney's office.

Barber agreed to plead guilty to the first two charges in exchange for dismissal of a third count.

Mark Andrus, a deputy Davis County prosecutor, said Barber sexually molested two 15-year-old girls during 1986 and 1987.

Barber remains free on his own recognizance and is scheduled to be sentenced June 14.
