This letter is to confirm our telephone conversation about Norman Hauswirth of 1920 South 32nd Avenue, Omaha, who has been Institutional Representative of our Troop #405.

Our troop committee has proof that Norm Hauswirth is a homosexual and that there has been at least three cases involving boys in our troop over the last two years. We have removed Mr. Hauswirth from our troop and have obtained an appointment for him at the Nebraska Psychiatric Institute in Omaha.

We would like to recommend the Mr. Hauswirth be prevented from ever participating in Scouting again.
