 Defendant present, represented by Hon. Wilson Rambo, waived formal arraignment and entered a plea of guilty to Fraud in Obtaining Public Assistance, and defendant was by the Court sentenced to serve six (6) months in the Ouachita Parish Jail; execution of sentence suspended and defendant placed on unsupervised probation for a period of two (2) years with conditions imposed which defendant stated she understood and accepted. Special conditions being that defendant make restitution and pay all costs of court within sixty (60) days. Amended Bill filed.

- #46,159 - State of Louisiana vs. Norman Hoyt Kee  
 Defendant present, represented by Hon. Val Salomon, waived formal arraignment and entered a plea of guilty to Contributing to the Delinquency of a Juvenile. Defendant was sworn and interrogated by the Court and advised of the right to pled not guilty and have a trial by judge or jury, advised if trial held of defendant's right to remain silent, against self-incrimination, confrontation, cross-examination and compulsory process, and the right to appeal or review by a higher court if convicted. Defendant indicated to the Court that he realized he was not obliged to plead guilty and that his plea was not influenced by any promises, persuasion or coercion on the part of others; knew the maximum penalty he faced and realized the Court and no other person would determine his sentence (see record of interrogation). The Court found the plea to be knowingly and intelligently and voluntarily entered and accepted said plea and ordered a pre-sentence investigation report returnable on or before May 23, 1988 and set sentencing on June 1, 1988, Courtroom #2 at 9:00 a.m. Amended Bill filed
