REPORT ON ORTTIS LLOYD SMITH AS RECEIVED FROM LT. BULLEN, DELAWARE STATE POLICE BY GUY V. SIMPSON, LS.E

On August 6, 1964, at approximately 5:00 P.M. one and one eighth mile off Howell School Road, Kirkwood, Delaware, Critis Lloyd Smith, 1503 Lancaster Avenue, Wilmington, Delaware was arrested for oral Sodomy on a thirteen year old boy. The boy is a member of Troop 22, Shildh Baptist Church. The boy involved was age 13, whose home address is Wilmington, Delaware.

This actually occurred at a place called Lums Fond. Smith reports that he took the boy out to the area to teach him about types of trees and wild life in the boy's work for a merit bage.

Smith talked to the boy about sex and girls and proceeded to unfasten trousers which dropped to the ground. He then unsnapped the boy's shorts which also dropped to the ground. At this point, Smith committed Sodomy "Peroris" on the person of the boy became frightened and ran away through the woods to a Service Station at Kirkwood, Delaware where the Station attendant called the Police.

First on the scene was 15. Ogder of New Castle Police Department.

Smith followed to the Station saying he was afraid the boy would become lost and he wanted to take him home. Smith was detained by Lt. Ogden who called roop 2 of Delaware State Police.


Detective frame Rassman arrived and questioned Smith. Smith admitted guilt and signed the confession. Magistrate Stefhrus of St. Georges, Del. set bail at \$500.00. Trial fill be in Superior Court.
