## Urbana man faces sex charge

An Urbana man who allegedly molested a young girl in his home is tentatively scheduled to be tried in May.

Osayimwese A. Most, 40, of 5 California Court was arraigned Wednesday on two counts of aggravated criminal sexual assault, a Class X felony carrying mandatory prison time as a penalty.

The charges allege that Most made inappropriate sexual contact with the 7-year-old Champaign girl in his home on March 13.

The child was there being cared for by Most's wife, who is a licensed day care provider.

Champaign County sheriff's investigator Ron Carper said he interviewed Most late last week after the allegations came to light, and that Most admitted molesting the child.

The incidents allegedly occurred in a locked playroom in the back of the Most residence, according to a deputy's report.

Most remained in the county jail this morning.
