We would very much appreciate your sending us a more detailed letter advising us of the nature of the information on the individual and a complete report on the situation, rather than just "taking indecent liberties with children". This information will be important as future reference and will serve to strengthen our position should we decide to refuse this man's registration.

I am sure you realize that this leaves Troop 212 without any registered unit leader. Undoubtedly, someone is taking over in this position. In order for the unit to continue to receive program inserts in Scouting Magazine, it will be necessary to advise this office of the name of the new unit leader. This should be done by filing with us an additional enrollment for this individual in his new position. Please do not file a separation notice as we have already dropped the current leader.

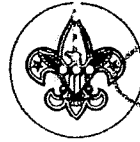
