On June 6, 1991, Deputy Regional Director Richard Parker brought to my attention the fact that Paul M. Jellum, a Scoutmaster in the Boulder Dam Area Council had been accused, in 1987, of sexual abuse of a teen aged boy in Logan, Utah. Mr. Parker advised me to call Neil Butterfield, Scout Executive of Cache Valley Council to get further information.

Mr. Butterfield informed me that accusations had been made regarding Mr. Jellum that resulted in Butterfield's issuing a registration suspension to Mr. Jellum. I asked Neil if he had given our National or Regional Offices copies of the letter and Neil said that although he thought he did, he couldn't be sure. Neil faxed me his notes on the situation, and after an examination of the notes, and a conversation with our Council Vice President for Risk Management, I wrote and delivered an additional suspension letter to Mr. Jellum based on the fact that his original suspension was never appealed.

I respectfully request that you pursue this matter with Neil Butterfield as it was in 1986-1987 in Cache Valley that the accusations and suspensions occurred.

I am prepared to cooperate with you in anyway you feel necessary.

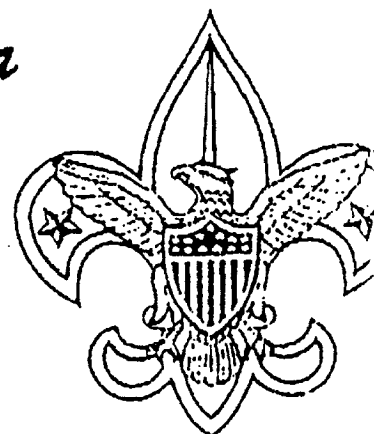
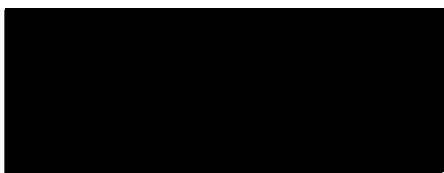



It has been brought to our attention that your registration privileges with the Boy Scouts of America were suspended in November, 1987 by the Cache Valley Council - Logan, Utah. It is also our understanding that you have not appealed that suspension through the Western Region office of the Boy Scouts of America as is required by National Boy Scouts of America policy.

We are therefore compelled to request that you sever any relations that you now have with the Boy Scouts of America including that of Scoutmaster of Troop 512 Arrowhead Ward Henderson West Stake as well as Camp Director, Camp Potosi Boulder Dam Area Council. Refund of your registration fee is enclosed.

Once again, as you have been informed, this decision can be reviewed by the Western Region Boy Scouts of America Review Committee. Please write to Regional Director Buford Hill, Western Region Boy Scouts of America, P. O. Box 3464, Sunnyvale, California 94088-3464 within sixty days of the date of this letter explaining your version of the facts supporting your claim that your registration as a Boy Scouts of America leader should be granted. The procedures for a review of this decision are attached.

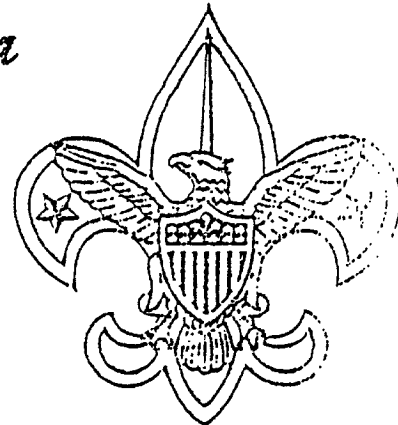

I've tried to reach you by phone for a week and have been unable to do so. I finally decided to call your in laws and get your address.

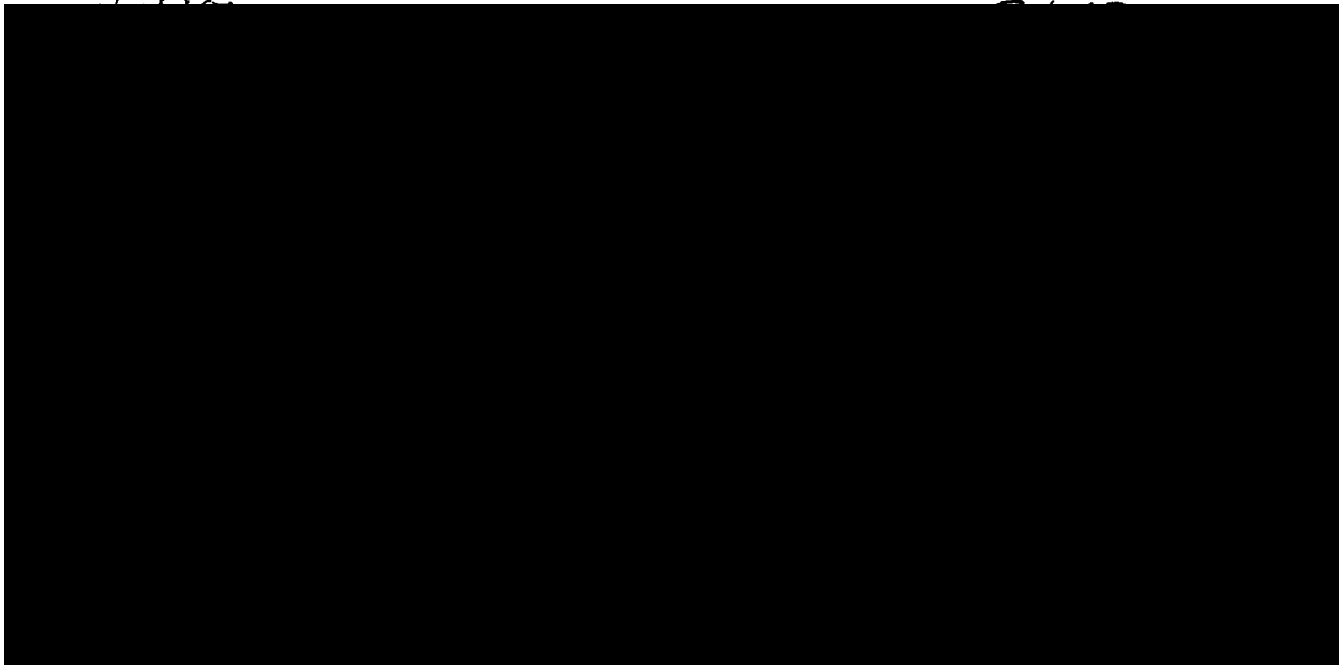

Thanks for your patience in my slow reply.

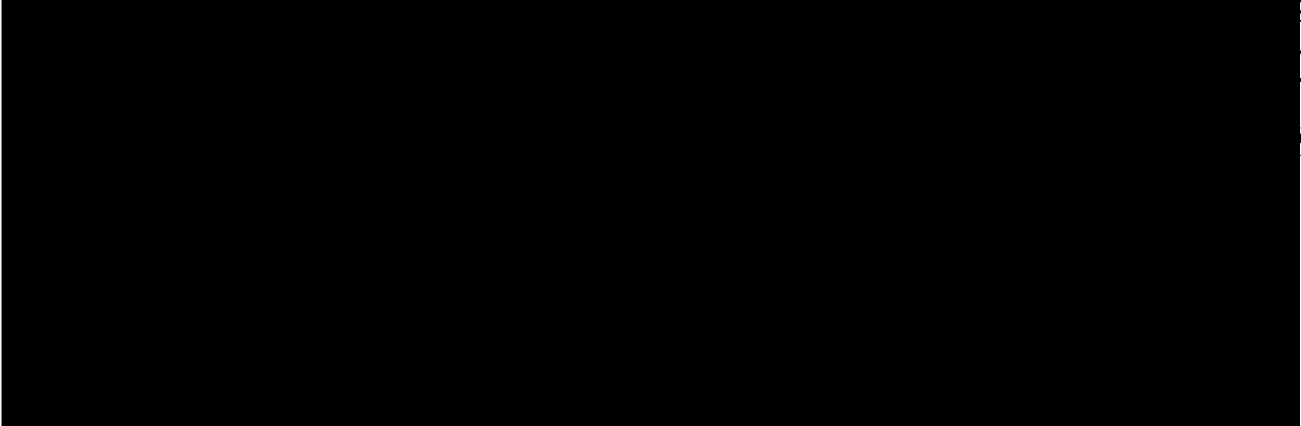
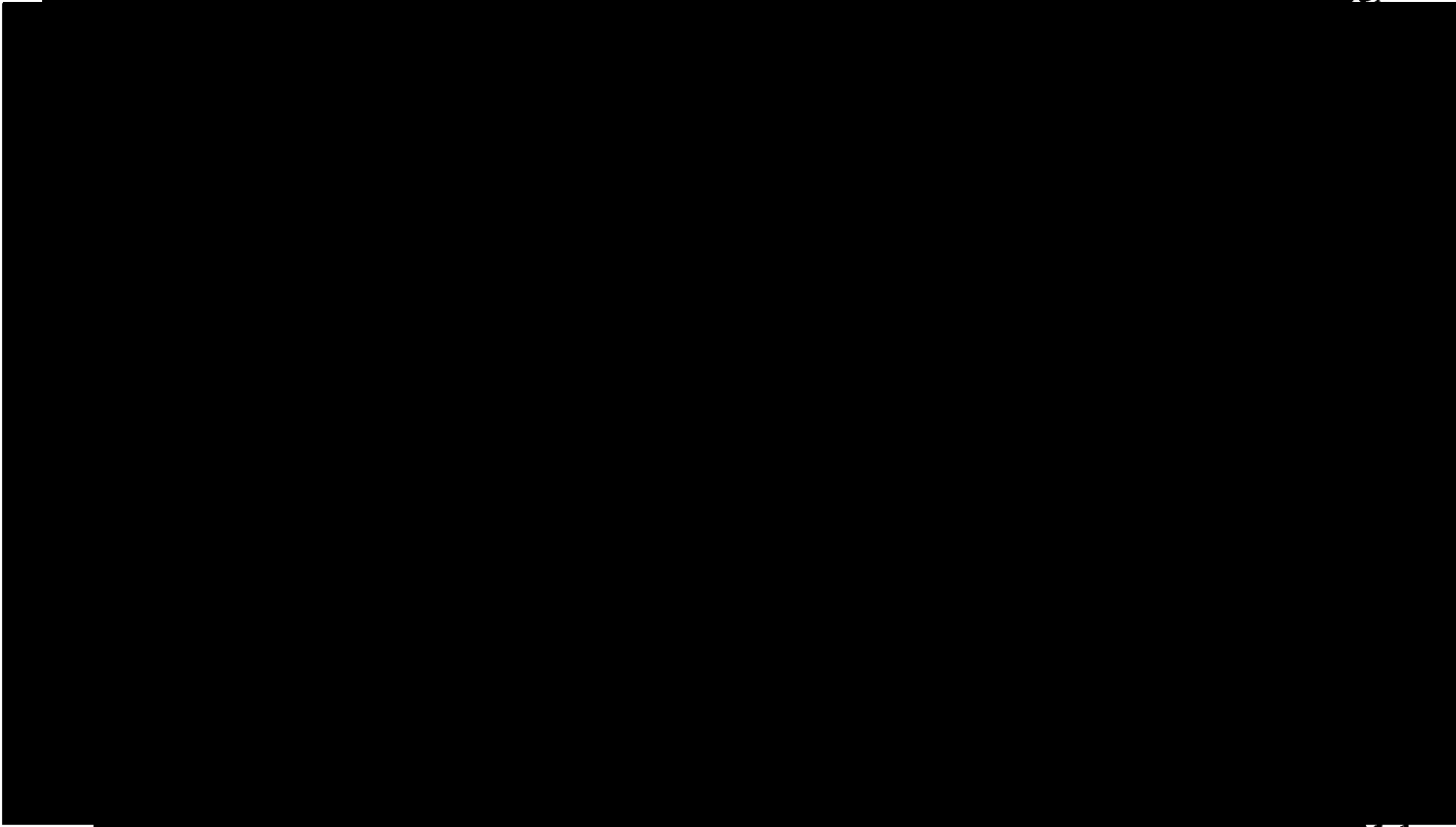

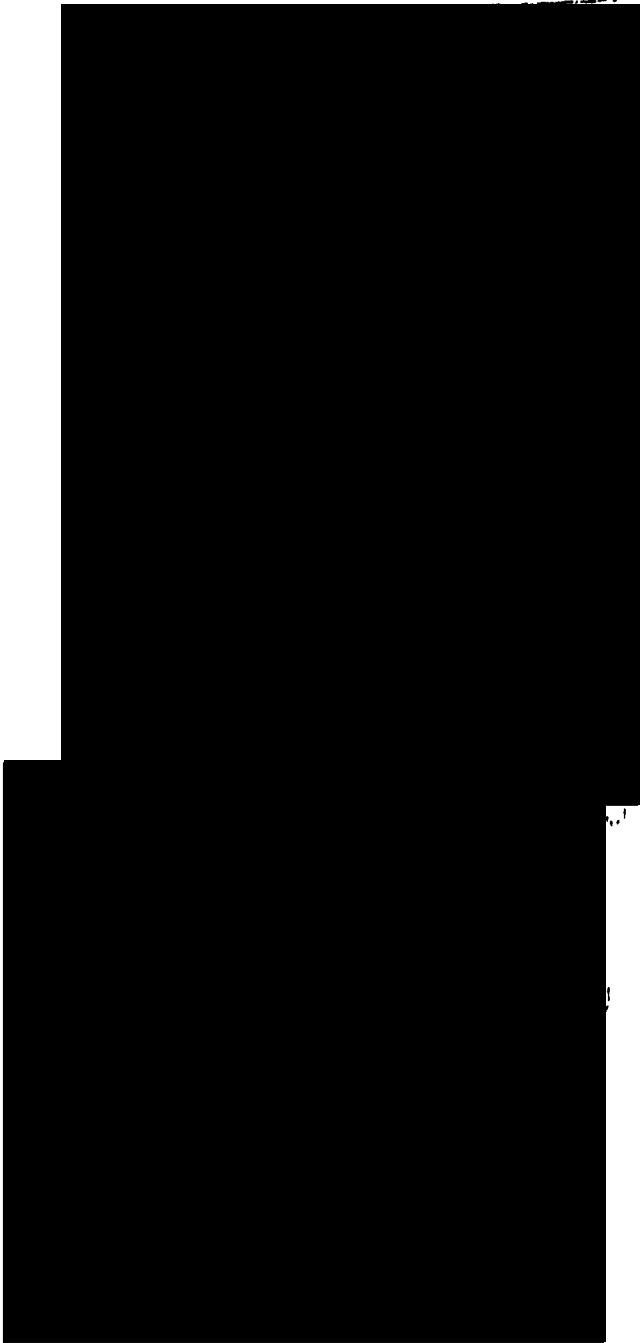

Tuesday Nov 3, 1987

Yesterday morning Nov 2, 1987 Joe Haddock informed me that a police detective had visited with him on Friday (11/1) requesting information on Paul Jellum who is being investigated on a sexual abuse charge that came from the complaint of a boy. The incident apparently happened at Camp Hunt in 1986.

Joe told me he gave Randy Auman, the police detective, copies of Paul's registration records. The detective had a subpoena *Deres Pecum* with instructions to the Boy Scouts of America, Cache Valley Council to deliver this records.

As a staff we reviewed the material and I did the training on Sexual Abuse as outlined by the BSA. From this material I determined that action must be taken so I called Richard Parker at the Regional Office to get advice. He told me that I should follow the procedure as outlined, type the letter and deliver it. He also said it would be a good idea to talk to the detective first hand and get the facts.

(0825am) I placed a call to the police department. The detective was not in but I left word for him to call me back. (As of yet he has not returned my call)

4:50 pm I typed the letter ~~in~~ to Paul Jellum on my typewriter in order to keep better confidentiality. I then met with Brent Haggan, the Council president, - to him what I knew. He did not want to sign it until I had confirmed the allegations by the police. We decided it would be best to wait until we talked to Randy Auman before we did anything about delivering the letter in case our involvement might hamper his investigation.

(8:00am) I called Boyd Ivie at Disneyland Hotel (██████████) as I had been instructed to do by Richard Parker. I apprised Boyd of the facts as I knew them. He said we were doing the right thing in waiting for an intake with Auman before delivering the letter. He said the only time constraint we had to worry about was reporting to the authorities and since it was the authorities that notified us we only had to take action to suspend Paul's registration.

I placed another call to Logan City police for Randy Auman. He called back a short time later and we talked about the case. He told me he was almost ready to interview Paul and would probably do so on Thursday. He said it would be best for us to wait until after he had interviewed to deliver our letter. It might hamper his investigation if we did so before. In talking to Randy he said as far as he knew no criminal action was intended because of the age of the boy. (14). He said the incident involved only fondling and the boy was old enough to give consent.

I then called Brent Hoggan and he agreed and said to call him when we were ready to deliver the letter.

11/5/87 8:20 am - I talked to Randy Auman this morning. He told me the interview had taken place, that Paul acknowledged the incident at Camp Hunt and that the department would probably charge Paul with contributing to the delinquency of a minor. He said delivering "the letter" would no longer interfere with his investigation.

11/11/87 Brent Hoggan signed the letter to Paul at 2:45 pm

11/11/87 At approximately 3:30 pm I called Paul Tellums home and left a message that I had called. At 4:10 pm Paul came to my office. I gave him the letter to read. Following his reading of the letter I told him we were making no acquisitions but our policy mandated the delivery of the letter. He said he expected it. He had already talked to his Bishop about his trouble. He indicated that the Police have no case, ~~but~~ he understood our position. He indicated his desire to return to Scouting when this was all over - I told him of the confidentiality that we would keep. We shook hands and he left the office.

4:45 Called Brent Hoggan and related the above to him

11/12/87 11:10 am Paul Tellum called me to inquire about the times the police department contacted our office. He again stated that he understood our position but that he was notarizing the letter and sending it to his attorney in Salt Lake (McConkie) because of the charges being brought by the mother of the boy.

11:15 am I called Boyd Ivie and read my notes on the case. He advised me to call Dave Park at the

home office and tell him that an attorney was being involved.

11:31 called Dave Park's office in Dallas - Paul is not in. I left word to call back.

Afternoon - Dave Park called back. I related the facts of the case to him. He said to have any attorneys that called call him.

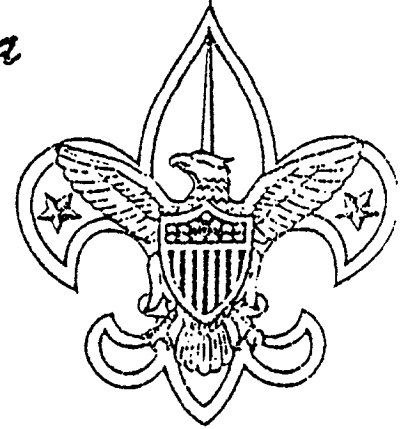


