Man Fined \$2,000 in Dedham Court

NATICK, April 21 — As the result of an extensive investigation by Chief W. Joseph Shea and Lt. Thomas McEvoy of the Natick police department, a 26-year-old Framingham man, a former resident of Brookline, was fined a total of \$2000 in Dedham court on Wednesday, on a 17 counts of contributing to the delinquency of minors, immoral behavior and for illegal possession of obscene pictures.

According to police, the actions took place on overnight camping trips in Dover with boys groups.

Suspicion began when the number of boys signing for camping trips dropped from 50 to about 12, and when one of the boys was questioned as to the reason for the drop, he told his father, who brought the boy to see Chief Shea. After hearing the boy's story, Chief Shea contacted Chief Chester Heinlein of Dover where the offenses allegedly took place and the three officers testified against the Framingham man at the Dedham court. He pleaded guilty in the Dedham court.

Juveniles in Court

A Jamaica Plain 16-year-old youth, picked up by Patrolman Robert Drew on Worcester St. on last Sunday evening, when he was reportedly seen staggering along the reservation, was before Judge Thomas Gunn in court yesterday, where he was found delinquent and had his case filed. He told police he had found a pint of liquor on the side of the roadway and had drunk it.

A Natick 15-year-old juvenile, taken into custody on Wednesday for shoplifting at Zayre's store was found delinquent in court yesterday and sentenced to the Youth Service Board, but his sentence was suspended and he was placed on probation.



It is with regrets that I must report the name of Paul Marshall Nathan of 140 Bishop Drive, Framingham, registered as Assistant Scoutmaster in Troop 134, Natick, Massachusetts.

Nathan is 26 years of age, married, has two children. He is a graduate of M.I.T. in Boston as an Electrical Engineer. He is employed with the Computer Control Company of Framingham. Nationality Jewish. Nathan was convicted in Court on April 18, 1962 on 7 counts of moral charges and is therefore unfit for further Scouting service. He was fined a total of \$2,000., put on probation and also put under the care of a Psychiatrist. Nathan was formerly registered in Troop 8 of Brookline, Mass., which is under the jurisdiction of the Boston Council. I have informed Scout Executive, Merle Hildreth of the charges.
