# Santa Fe Man Sentenced To 18 Months in Prison

A Santa Fe man described in court as a "situational pedophile" was sentenced to 18 months in prison Tuesday for child molesting despite a recommendation by District Judge Petra Maes and others that he be considered for probation.

A Santa Fe County grand jury indicted Paul Sanchez Sr. in May on charges that he exposed himself and molested four young girls at a party at someone else's home on Sept. 1, 1986. He also was charged with the attempted molesting of a young girl at his home on Sept. 6, 1986.

An affidavit for Sanchez's arrest said the girls' parents had seen Sanchez make several trips into a room where the children were playing the night of the party, but didn't think anything of it at the time. The children later told their parents he had sexually molested them, according to the affidavit.

Sanchez, 38, entered into an agreement with the District Attorney's Office last month and pleaded no contest to two lesser charges of attempted criminal sexual contact of a minor.

In an Oct. 23 letter written on Sanchez's behalf, Judge Maes said she had worked with him and his family over a two-year period to establish a Cub Scout-  
ing program for their sons.

"I strongly believe that Paul is the type of individual who works hard to improve himself. Given the opportunity, he will learn from his actions and correct his situation," she wrote.

The letter, addressed to "To Whom It May Concern," was typed on letterhead from the First Judicial District. Maes signed it as "Parent and Cubmaster, Pack 28."

During the hearing on Tuesday, the Rev. Frank Brito of San Isidro Catholic Church said, "I can't say enough good things

about him."

In sentencing Sanchez, District Judge Art Encinias said there are very few crimes more reprehensible than those in which children are victims.

The judge said he was puzzled how a man so admired could also be a sexual abuser of children. The judge said that, in his opinion, Sanchez had forever shattered the children's already fragile world.

Encinias ordered Sanchez to seek substance-abuse counseling and therapy designed for sex offenders. He also ordered Sanchez to repay the victims' families for psychiatric counseling for their children.

Michael J. Dougher, director of the Psychology Department at the University of New Mexico, said that based on a comprehensive evaluation he believed Sanchez was a "situational pedophile."

He said Sanchez only seeks children out for sexual gratification under certain situations, typically when he's intoxicated. Dougher said Sanchez had been sober for 1 1/2 years.
