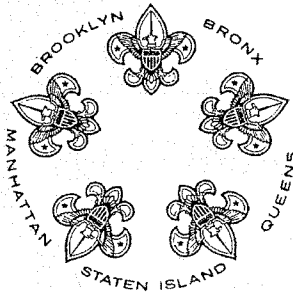

Dear Mr. Paolini:

In regard to the incident concerning Mr. Graf, the following is a record of the actions in question.

On the night of August 21, 1961 while residing as a house guest of the [redacted] family at [redacted] Staten Island 5, Mr. Graf shared a room with [redacted] a member of Troop 65. By Mr. Graf's own admission he, during the night, fondled [redacted] genital organs; assuming the boy was asleep.

The next morning, [redacted] reported the incident to his parents. They, in turn, confronted Mr. Graf with the reported details, which he freely admitted. The troop was then at Summer Camp and Mr. Graf telephoned the Scoutmaster, Mr. [redacted] to inform him that he was resigning as Assistant Scoutmaster and relating his reasons for such action.

The committee removed Mr. Graf from his position on August 23. Notification to Council was withheld until Mr. [redacted]'s return from camp.

Mr. [redacted] reported the details to you verbally. This report was followed by my letter to you advising you of the Troop Committee's action. This letter is in response to your request for clarification of the issue.

I have since learned that the real reason was that this man, Peter Graf, was accused by one of the Scouts that Peter Graf slept with this boy one night and made improper advances. The boy told his parents and when the man was questioned, he admitted all. I have tried to get this information in writing from the Committee Chairman but he is not willing to put it in writing at this time. *The boy and his family have since moved out of our Council.*
