Received a letter from Paul Ernst indicating that Garon had written the National office indicating that he had been molested in Scouting and has also been a molester himself. Ernst asked Cree to see if any information was available locally.

3/31/90

Cree wrote to Ernst reporting that nothing had been found locally but offering to check with cooperating authorities if this would be in order. No records exist indicating any local affiliation with the Boy Scouts of America.

10/3/90

Ernst called Cree asking that any information and files that Cree has regarding Garon be copied and sent to Ernst which was done.

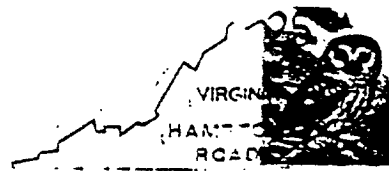

Dear Sir,

I'm writing this letter in regard to an incident that happened to me almost 20 yrs ago. I was a member of troop 8, operating out of the Jewish Community Center on Haverhill St in Methuen, Ma. My scoutmaster was Carmie Middlemiss. On two or three occasions, he sexually molested me on camping trips.

I'm not writing this letter for revenge I'm only concerned with the welfare of other boys. I have grown up to be a child molester myself and alot of my problems stem from being molested by Mr Middlemiss.

I'm not asking you to start an investigation I'm just asking for you to please keep an eye on his troop, if he is still involved in scouting. I realize that I should have told someone as soon as these incidents happened, but, I was scared, when child molesting wasn't publicized like it is today. I was uneducated and didn't realize that

help was available, I hope that I can help other kids with this letter.
