

The attached papers cover our processing and handling of a recent suspected and by investigation by Detective Gary Roeloff, of the Grand Rapids Police Dept., found guilty as reported by one 15 year old Scout, who refuses to take the case further and testify. Twenty-four (24) hrs. after the Scout [redacted] was interviewed Phil Miller sent a letter of resignation to the head of his troop's sponsoring organization and copied our EE Carol Vink.




