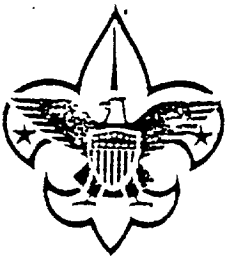

DETAILS OF INVESTIGATION

KILLED INJURED

The victim belonged to the [REDACTED]. The defendant was his coach during the sons of 1984 and 1985. During the Spring of 1985, in early June, there was a sleep over at the above location for all soccer participants and their coaches. The sleep over took place in the gymnasium of the [REDACTED] Y. While the victim was laying next to the defendant on the floor of the gymnasium during the bedtime hour, the defendant reached over putting his hands under the underpants of the victim and began fondling victim's genital area for a lengthy period of time.

The victim also relayed to Officer Sherman that the defendant would take the victim in his car after soccer practice on a regular basis, sit the defendant on his lap and kiss him on the lips. The victim stated that the defendant told him that he looked like his deceased son and therefore he loved him very much. The victim stated this occurred too many times to count during the 1984/1985 soccer seasons.

It wasn't until the month of August 1988 that the victim made his father aware of incidents that had occurred in June of 1985. Father did not come to the police until December 21, 1988. He was not sure on what course of action to take.

DECEMBER 27, 1988 AT 8:27 A.M. THE DEFENDANT VOLUNTARILY APPEARED AT THE LIVONIA POLICE STATION, WAS ADVISED OF HIS RIGHTS PER MIRANDA AND SIGNED A LIVONIA POLICE DEPARTMENT ADVICE OF RIGHTS FORM. AFTER SIGNING LISTED FORM, THE DEFENDANT GAVE BOTH AN ORAL AND WRITTEN STATEMENT ADMITTING TO THE FONDLING OF THE VICTIM IN THE LIVONIA Y GYMNASIUM IN JUNE OF 1985. HE STATED, 'I'M NOT SURE WHY I DID IT BUT I WAS STIMULATED BY MY ACTIONS'. IN REGARDS TO THE TAKING OF THE VICTIM INTO HIS CAR AFTER SOCCER PRACTICES, SITTING HIM ON HIS LAP AND KISSING HIM, THE DEFENDANT ADMITTED TO DOING THIS ON ONLY ONE OCCASION. HE STATED HE COULD NOT REMEMBER DURING WHAT TIME OF THE YEAR THAT OCCURRED. DEFENDANT WENT ON TO SAY THAT HE REALIZED AFTER THE INCIDENT IN THE LIVONIA Y GYM WITH THE VICTIM THAT HE NEEDED HELP AND STATED HE WOULD SEEK HELP AFTER THIS INCIDENT. DEFENDANT COULD NOT RELAY INFORMATION IN REGARDS TO PERSON HE SOUGHT HELP FROM.
