# Man Is Arrested For Assaulting Boy

A 29-year-old Boulder man was arrested Tuesday for sexual assault on a child after a 14-year-old boy complained that the man had forced him into sexual relations.

Ray Lewis Bieber, 7779 Devonshire Way, was arrested at the Boulder County Sheriff's Department, and released on a \$10,000 personal recognizance bond.

Bieber's arrest followed a two-month investigation into the claims of a 14-year-old Boulder youth who met Bieber through a Boy Scout Troop where Bieber was assistant leader.

The boy told detectives at that a friendship with Bieber revolved into a sexual relationship last April which continued until Sept. 23, 1977.

NATURE OF REPORT: R/O continuing investigation on above case.

DETAILS: In reviewing the case, it was determined that the New York information would most probably be beneficial in prosecution of the case in this jurisdiction. Working through the District Attorney's Office, P/O processed an affidavit for the arrest of the suspect and obtain a warrant for his arrest through Judge Scott. The suspect would be referred to Community Corrections by the District Attorney's Office in lieu of criminal prosecution. It was stated to R/O by Mr. Bill Fritzel of the District Attorney's Office that if the suspect refused to cooperate with the Coor mity Corrections arrangement, criminal charges would be filed. Arrangements were made by Bill Fritzel through the attorney of the suspect, Mr. Greg Martin, to have the suspect surrender himself to R/O on 1/31/78. Further, Mr. Fritzel recommended that R/O deliver to Community Corrections a copy of the case facts. R/O contacted Barbara Fitzgerals of Community Corrections and delivered to her the case facts. Ns. Fitzgerald requested that R/O meet with her on 2/10/78 to review the case history.

1/31/78 - The suspect appeared at R/O's office in the presence of his attorney for the purpose of arrest. The suspect was booked on charges of Sexual Assault on a Child and released to the Community Corrections Diversion Program. R/O advised the complainant of below disposition.



#### AFFIDAVIT FOR ARREST WARRANT

The affiant, Detective Richard Dutrow, a commissioned officer with the Boulder County Sheriff's Department, County of Boulder, State of Colorado, being duly sworn deposes and states that:

Mr. stated to the affiant that he had been in contact with Mrs. on 10/3/77 who expressed her concern that her 14 year old son identified in, DOB 4/6/63, may have experienced some sexual activity with an assistant scout master of Boy Scout Troop 177, identified as Ray L. Bieber, DOB 3/15/48. Stated to Mr. Stated to M observed that was upset resulting in Bicber getting dressed and return to his own residence. Mr. related to the affiant that on 10/3/77 he spoke with Javre who related that he was sleeping with Ray Bieber at s residence, County of Boulder, State of Colorado. , County of Boulder, State of Colorado. he awoke to find Mr. Bieber masturbating him. It was also related that Mr. Bieber had performed a form of anal intercourse on \_\_\_\_\_. On 10/6/77, the affiant met with Mr. and Mrs. n. Mrs. stati that she was awakened by her son, at approximately 0030 hours on 9/21/77 appeared to be upset resulting in her asking what the problem was.

informed his mother that Bieber was a "fag" and that he couldn't sleep with Bieber anymore. A few minutes later, Bieber got out of set bed and observed that and Mrs. A set upset resulting in him getting dressed and returning to his own residence. Mrs. located at , County of Boulder, State of Colorado. On 10/6/77, the affiant held a conference will at the Department of Social Services with the assistance of John Dean of that agency. that the molestations began to occur in April of 1977 continuing through the summer until the most recent occurrance on 9/23/77. stated that on 9/23/77 Ray Bicber was at his residence assisting in school work when at approximately 2200 hours both he and Bieber went to hed.

bed and both were wearing underwear only. At approximately 2230 hours, Ray Bieber placed his hand underneath sunderwear, grabbing hold of spenis. Ray Bieber began to masturbate. Rieber began to masturbate for about 20 minutes according to stated that Ray Bieber may have thought he was asleep during the activity. rolled over on his stomach to cease the molestation, however, Bieber then laid on top of him placing his penis into the anal cavity of the performing anal intercourse. stated that Bieber performed this activity for several minutes after which got out of bed and informed his mother that Bieber was a "fag" and that he did not desire to sleep with Bicher any more. further stated that during the month of May, 1977 he and Ray Bicher were in Bicher's vehicle en oute to Boulder from Heatherwood Subdivision where a conversation ensued about sleeping habits. related to Bieber that he could awaken easily by physical contact and not very easily by noise. Ray Bieber responded by stating "You wouldn't believe things I do to you when you are asleep." Turther related that after his scout troop was presented a crime prevention program on child molestation in April of 1977, Ray Bieber stated to that "Most people that both male and female." experience sex with both male and female.'

On 10/11/77, the affiant interviewed Mr. Ray Bieber who after being duly advised of his constitutional rights per Miranda stated that he became acquainted with the victim during September of 1976 during boy scout activities. Mr. Bieber volunteered to assist scholasticly. Mr. Bieber began to meet with at the residence upon a regular basis. Mr. Bieber stated that on at least three occasions during the past year, and he held conversations about sexual matters. Bieber stated that he viewed himself as a primary educator in sexual matters with pointing out that the parents have not educated their son concerning those matters. Mr. Bieber stated that asked him about what type of sexual activity occurs between homosexuals resulting in Mr. Bieber going anto detail explaining mutual masturbation and anal intercourse. Mr. Bieber related

that during the times that he was sleeping with that he most probably became in sexual contact with however, he states that if he did it was unintentional.

On 11/22/77, the affiant, through interviews of persons in the Boulder area, developed information that Ray Bieber had developed a similar close relationship with a New York State boy during the year of 1976 while Bieber resided in the vicinity of Poughkeepsie, New York. Investigation concerning that matter is continuing by the Boulder County Sheriff's Department and New York authorities.

The affiant feels that he has shown sufficient probable cause to believe that the defendant, Ray L. Bieber, DOB 3/15/48, described as being USMM, 5'9", 160 pounds, blond hair, blue eyes, residing at 7779 Devonshire May, Boulder, Colorado, did in fact commit the crime of Sexual Assault on a Child, contrary to 18-3-405, C.R.S. 1973 as amended and requests that the court issue a warrant for his arrest.
