

Raymond H. Smith should be placed in the Confidential File because of his arraignment on January 18, 1964, for immoral conduct with beyon.

Following the hearing, he was bound over to the Grand Jury.

Smith worked as a volunteer for some 12 years at the Oakdale Home for Boys at Oakdale, Pa. He left there sometime in 1962, stating as his reason disagreement with professional personnel at the Home.

Following the arraignment, our first knowledge of this case, we consulted with the Oakdale Superintendent who advised us that Smith was told to leave the Boys' Home for reasons of immoral conduct.

At the Home, Smith also caused problems between the Superintendent and employees, with some employees being dismissed as a result of Smith's agitation. The statement from the Superintendent of the Home was very positive as to his immoral conduct.

Smith was relieved of his duties by the Pennsylvania Railroad as of January 13, 1964, until this matter is entirely cleared up. We are now advised by the Railroad that Smith had been under suspicion for some time since several younger trainees refused to work with him.

Smith had been a Charter Member of the Lions Club in McDonald, suddenly drepping his membership in 1961 with no logical explanation.

Mr. Bugay, as Squire and Mayor, indicated his conduct as the reason for Smith leaving the Lions Club, further stating this arrest did not surprise local people.

He had been Commander of the McDonald American Legion, serving in 1964 as Finance Officer. Smith has resigned as Asst. Cubmaster of Pack 94, McDonald. After our investigation, there seems to be little doubt as to his immoral conduct.




