On 4-14-88 we received a phone call from a concerned parent concerning Reginald Mosher. This woman had made some comments concerning Reggie abusing [redacted] no reference was made to the kind of abuse.

Upon calling the D.S.S. we were told to get a signed release from Reg for us to receive any additional information from them. Reginald came in to sign the release and admitted to sexual abuse of [redacted] 4 years ago at which point he was asked to resign. (submitted 4/20/88)

It was later learned that the abuse was not limited to one instance with [redacted] also may have involved [redacted]

He is currently undergoing treatment thru D.S.S.

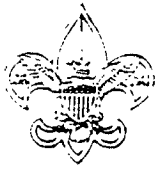
