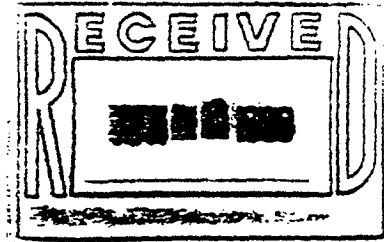

We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review board, please write me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

# Restaurant owner guilty in sexual assault

PROVIDENCE — A North Attleboro man has been found guilty on three counts stemming from a sexual assault in his Cumberland restaurant.

Regis Jette of Plain Road North Attleboro, was found guilty of one count of first degree sexual assault, one count of second degree sexual assault and one count of abominable and detestable crimes against nature (oral sex).

He was found innocent of two other counts of first degree sexual assault, one involving a foreign object — a stick of pepperoni — and the other involving penetration with his finger.

The Superior Court jury deliberated for six-and-a-half hours before reaching a verdict. The verdict climaxed a

After the jurors Judge John O'Leary.

Jette was arrested in his home in the early morning of March 19, 1988, and charged with the five sexual-related crimes.

Police charged that Jette brought a woman, 28, Kevin's Restaurant on Old Algonquin Road, in Cumberland, after a date, where he then allegedly attacked and beat her, then raped her.

Both Jette and the victim agreed the two were together in the restaurant sometime

after midnight and that they did cocaine together.

The woman said Jette then attacked her, slapping her face, pounding her head on the floor and ripping hair from her head, leaving bald a patch the size of a quarter on the back of her head.

During the assault, the woman said, Jette sexually assaulted her with a stick of pepperoni.

Jette argued the two were together. Because of the, claiming he could not perform sexually, he testified.

When the woman asked for some phallic object after Jette's failure, he went to the restaurant refrigerator looking for a cucumber, Jette testified. When she would not find a cucumber, he offered the woman her choice of a hot dog or a pepperoni and she chose a pepperoni, he testified.

While they were heating the pepperoni over the stove because it was cold, Jette testified, the woman became upset and began throwing things around the business. Jette said that at that time he left the business and went home.
