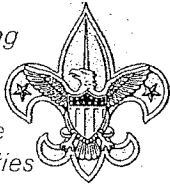

A man by the name of Richard Armour Knight has been arrested in Marin County, California on charges of contributing to the delinquency of minors and failure to register as a convicted sex offender.

Mr. Knight was serving as in Neighborhood Commissioner in both the Marin County Council and the San Francisco Bay Area Council, and at the time of his registration through the San Francisco Bay Area Council, he possessed an unexpired registration card with the South Florida Council, Troop 13, where he had been serving as an Assistant Scoutmaster.

Current information indicates that it was a Florida conviction in 1961 for sex violations which is the cause of booking him on failure to register as a previously convicted sex offender.

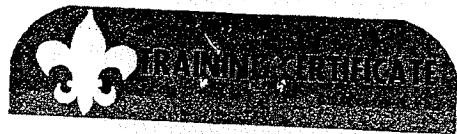

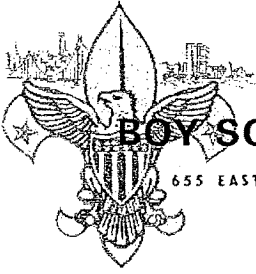

We have been advised by the Sheriff's Office of Marin County that Richard Armour Knight has been booked in the county jail on the charge of contributing to the delinquency of minors and failure to register as a convicted sex offender.

I am sending along photostats of the newspaper article which appeared last week in the Independent Journal, a daily newspaper which circulates in Marin County. We will watch for further developments at the Marin Municipal Court. However, may we suggest that you contact the South Florida Council, inasmuch as the Sheriff's Office here states he was convicted in Florida in 1961 for sex violations.

This man should be placed on the Confidential File. He is currently registered as a Neighborhood Commissioner in our Golden Acorn District. We have contacted him and requested he return his registration card and all cards identifying him with the Scouting program. And, of course, he has been dropped from the Commissioner Staff.

His mailing address is 555 Buena Vista West, San Francisco; business phone 832-7600; home phone 626-6657. He has been registered as a Neighborhood Commissioner, which registration was due to expire June 30. He works as a Sales Representative for Remington Rand; is not married, is 30 years of age; is a U.S. citizen; and at the time of registration as a Neighborhood Commissioner in December 1965, he possessed an unexpired registration card with the South Florida Council, Troop 13, where he was serving as an Assistant Scoutmaster. He indicates a religious preference of Protestant.

Would you kindly forward appropriate forms for identification normally used. In the meantime the possession of the above facts, plus photostats, plus your own inquiry of South Florida Council should help to document this file more accurately.

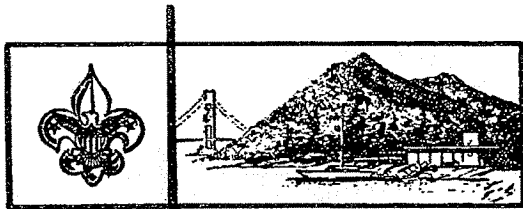

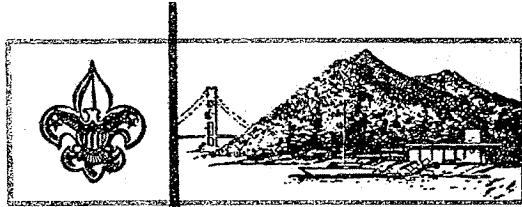
