Area man gets 8-25

in sexual abuse case

A former scoutmaster of a Huntington Boy Scout troop was sentenced to 25 years in prison for sexually abusing members of the troop.

attended the hearing. But after listening to the plea, O'Hanlon began listing his sentencing options and explained how he reached his decision.

"You are a true pedophile," O'Hanlon told Aluise, referring to a person who has sexual desires toward children.

O'Hanlon said he studied in detail psychiatric reports of Aluise's life and accused the defendant of purposely placing himself in roles, such as scoutmaster and athletic coach, to satisfy his desires.

Aluise, formerly of Barboursville, was arrested last Oct. 4 on warrants obtained by the state police and the youth and sex division of the Huntington Police Department.

The warrants were based on complaints that involved reported incidents of sexual abuse and sexual assault during June 1984 at Camp

Arrowhead near Ona. At the time of the incidents, Aluise was scoutmaster of Boy Scout Troop 99 at Our Lady of Fatima Catholic Church.

O'Hanlon said that based on polygraph reports and psychiatric examinations, Aluise sexually abused or sexually molested about 10 scouts over several years.

Few pedophiles who exhibit such behavior over a long period of time ever overcome such sexual impulses, the judge told Aluise. "While you're free, every young boy in our community is at risk," the judge said.

He then gave Aluise the maximum prison sentence for each offense — one to five years for each sexual abuse charge and five to 10 years on the sexual assault, all to be served consecutively.

"And may God have mercy on your soul," O'Hanlon concluded.

As the sentence was handed down, Mrs. Aluise became distraught in the courtroom and later screamed at parents who attended the hearing. "How can they do this to us?" she asked.

During the hearing, defense counsel asked that Aluise not be sent to prison and requested that instead he be placed in a treatment program.

"I think the man needs treatment and it's the kind you don't receive in our penal institutions," said William B. Webb, executive director and a psychotherapist at Holistic Health Center Inc. Webb has treated Aluise.

A Cabell County grand jury indicted Aluise last November, charging him with three counts of first-degree sexual abuse and one count of first-degree sexual assault. Through a plea agreement, the state allowed Aluise to plea guilty to the sexual abuse offenses and the reduced sexual assault charge.

After pleading guilty last April, Aluise was ordered to undergo a 60-day evaluation at Huttonsville Correctional Center.

Aluise was taken to the Cabell County Jail after yesterday's hearing to immediately begin serving his sentences.

WEEK OF SEPTEMBER 10

Assistant Scoutmaster, Jim Butcher of Troop 99, Our Lady of Fatima Church, telephoned Council staff member Jack Brun and reported that one or two Scouts in the troop had reported incidents of sexual abuse involving Scoutmaster Richard Aluise indicating the parents intended to bring criminal charges.

WEEK OF SEPTEMBER 17

Council President Charles Bagley, III, an attorney, received a telephone call from the Cabell County prosecutor's office indicating Mr. Aluise had been charged. Mr. Bagley and I kept in communication with each other on the matter daily. I telephone Barclay Rollas in the National Office for advice, anticipating contact from the news media. I also discussed implementing "standards of leadership" action with Paul Ernst of Registration Service. Later in the week I received calls from Harold Freizel of Risk Management and Joe Kessler of Catholic Relationships.

Rumors regarding the incident spread throughout the community and I was asked about it several times each day.

I learned the Troop 99 committee had appointed the assistant leaders to handle all meetings and activities. I was also told Mr. Aluise had resigned his responsibility as a soccer coach.

WEEK OF SEPTEMBER 24

When it became apparent that the County Prosecutor's office did indeed have a case with substance against Mr. Aluise, I had the recommended letter from the "Standards for Leadership" typed on September 25. President Bagley signed it two days later. We discussed the advisability of hand delivery, however, Mr. Bagley elected to send it by mail. (Copy attached.)

THURSDAY, OCTOBER 4

Mr. Aluise was arrested. See attached news clipping dated October 5.

FRIDAY, OCTOBER 5

Jim DeBord, Chairman of Troop 99 committee came to the office to see me to ascertain the Council's position regarding the alleged incidents. I informed him the Council would be most supportive of the church's action to select new leadership continue the proud tradition of Troop 99. He invited me to attend a troop committee meeting at his home Monday, October 8 at 7 p.m.

TUESDAY, OCTOBER 9

I did not attend troop committee meeting, however, I did phone the committee chairman and he informed me the head of the chartered organization, Father Frederico, and the troop committee had met and selected a new Scoutmaster.

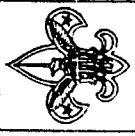
That afternoon I phoned Paul Farrell, Assistant County Prosecutor, and asked him the status of the case. He informed me that a city detective and state trooper were continuing the investigation and that two of the boys whose parents had brought charges had been given polygraph exams which affirmed positive. He indicated that the nature of the offenses included oral sex and several other abuses. He said although the preliminary hearing was set for Tuesday, October 16, he expected Mr. Aluise's attorney to seek a continuance.

I personally visited Father Frederico to assure good Council/sponsor relationships with Our Lady of Fatima Church and be certain there was direct communication "pro to pro". I gave him a copy of the letter which had been sent to Mr. Aluise by President Bagley.


Dear Mr. Aluise:

Cabell County resident arrested

A Cabell County man was arrested yesterday on two counts of first-degree sexual abuse and one count of first-degree sexual assault in connection with a reported incident last June at Camp Arrowhead near Ona. Prosecutor John L. Cummings said.

The suspect, identified as Richard Aluise, 37, of 7 Meacham Drive, was arrested on warrants obtained by state police and the youth and sex division of the Huntington Police Department, Cummings said.

The warrants are based upon complaints received by state police and the youth and sex division concerning alleged incidents involving two juveniles, aged 11 and 14, Cummings said.

At the time of the alleged incidents, Aluise was scoutmaster of Boy Scout Troop 99 at Our Lady of Fatima Catholic Church, Cummings said. The juveniles were members of the troop, he added.

Aluise was taken before Magistrate Alvie Qualls about 7:45 p.m. and released on \$20,000 bond, the magistrate said.

Arraignment is scheduled for 9 a.m. Tuesday, Qualls said.

Trooper Dennis Foreman and Sgt. Darrell Black, commander of the youth and sex division, are heading the investigation, which is continuing, Cummings said.

"The scope of the case is more than just these three warrants," Cummings said. He declined further comment.

Plea of Innocence entered

An innocent plea has been entered in Cabell County Magistrate Court on behalf of a county resident accused of two counts of first-degree sexual abuse and one count of first-degree sexual assault in connection with a reported incident last June at Camp Arrowhead near Ona.

Richard Aluise, 37, of 7 Meacham Drive was arrested last week on warrants obtained by state police and the youth and sex division of the Huntington Police Department concerning alleged incidents involving two juveniles, aged 11 and 14.

Aluise's lawyer, John Hankins, entered his client's innocent plea Tuesday before Magistrate John Ray Rice. A preliminary hearing for Aluise is scheduled for 10 a.m. next Tuesday.

At the time of the alleged incidents, Aluise was scoutmaster of Boy Scout Troop 99 of which the juveniles reportedly were members. Prosecutor John L. Cummings has said.

Aluise remains free on \$20,000 bond.

Sexual abuse hearing postponed

A preliminary hearing was continued yesterday in Cabell County Magistrate Court for a county resident accused of two counts of first-degree sexual abuse and one count of first-degree sexual assault in connection with a reported incident last June at Camp Arrowhead near Ona.

Court proceedings for Richard Aluise, 37, of 7 Meacham Drive have been postponed until Nov. 13, said Magistrate William R. "Bob" Baker. Prosecutor John L. Cummings said the hearing was delayed because a state witness wasn't able to attend.

Ex-scoutmaster pleads guilty to sexual abuse

HUNTINGTON, W. Va. (AP) — A scoutmaster who admitted playing strip poker with three Boy Scouts and assaulting a fourth has pleaded guilty to three counts of first-degree sexual abuse and one count of second-degree sexual assault.

Richard Aluise, 37, entered guilty pleas Friday. Cabell County Circuit Judge Dan O'Hanlon then ordered Aluise to the Huttonsville Correctional Center for a 60-day evaluation prior to sentencing.

Asked if he were guilty of the charges, Aluise, formerly of Barboursville and now of Chesapeake, Ohio, said, "Yes sir."

Aluise said he played strip poker with three Scouts last summer while camping at Camp Arrowhead near Ona. He said he also placed his mouth on the body of another boy.

At the time of the incidents, Aluise was Scoutmaster of Boy Scout Troop 99 at Our Lady of Fatima Catholic Church. He was arrested last October on warrants obtained by the state police and the youth and sex division of the Huntington Police Department.

Aluise must report to the Cabell County Jail on May 8, to be transported to Huttonsville. Aluise, who said he is currently seeing a psychiatrist, faces a maximum sentence of 10-to-20 years for sexual assault and one-to-five years on each of the sexual abuse charges, plus a possible \$20,000 in fines.

As part of a plea agreement, Cabell County Prosecutor John Cummings said he has agreed not to prosecute Aluise on other charges. Cummings said he also has promised to remain silent on what sentence he believes the defendant should receive.

Man enters guilty plea to sex charges

A former scoutmaster pleaded guilty yesterday in Cabell County Circuit Court to three counts of first-degree sexual abuse and one count of second-degree sexual assault.

In a hearing before Judge Dan O'Hanlon, Richard A. Aluise, 37, formerly of Barboursville, said that he played strip poker with three Boy Scouts and there was "a minimal amount of touching," and that he placed his mouth on the body of one.

Asked by O'Hanlon if he was guilty of the charges, Aluise replied, "Yes, sir."

First-degree sexual abuse carries a penalty of one to five years in prison or a maximum fine of \$10,000 and Second-degree sexual assault car-

Aluise was indicted last November on three counts of first-degree sexual abuse and one count of first-degree sexual assault.

Prosecutor John L. Cummings told O'Hanlon that through a plea agreement the state agreed to allow Aluise to plead to the lesser sexual assault charge.

He was arrested last Oct. 4 by city and state police on warrants based on complaints received by authorities about alleged incidents of sexual abuse and assault last June at Camp Arrowhead near Ona, W. Va. Aluise

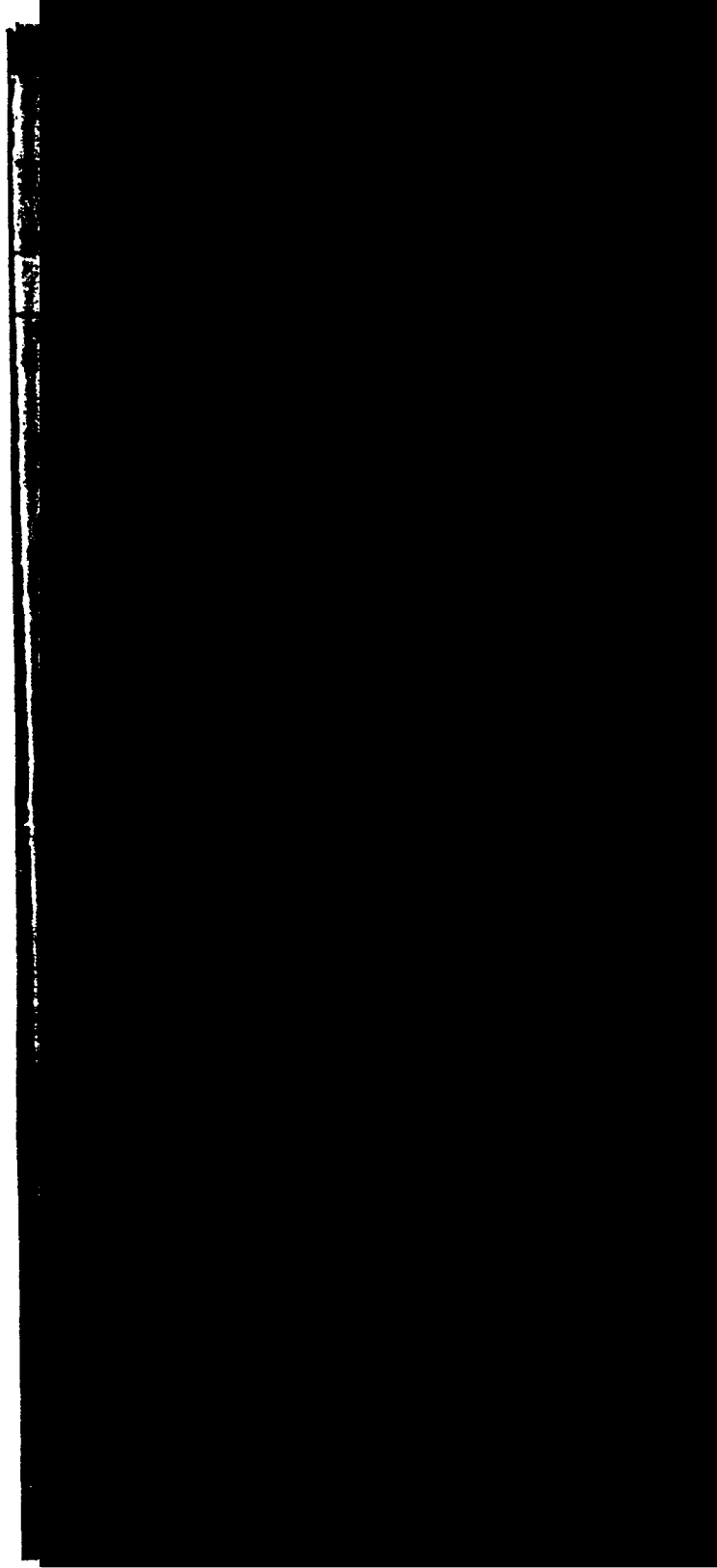
