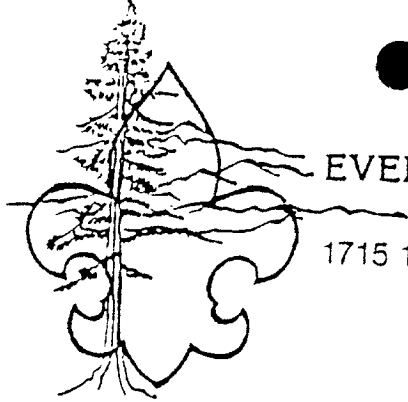

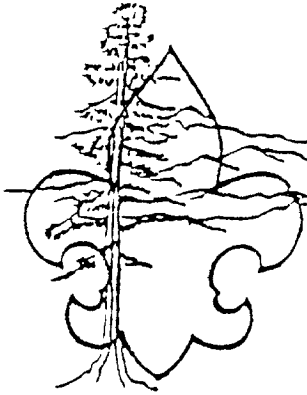

Dear Mr. Osner:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a regional review committee please write to Richard Harrington, Regional Director, 185 North Wolfe Road, Sunnyvale, California 94086, within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

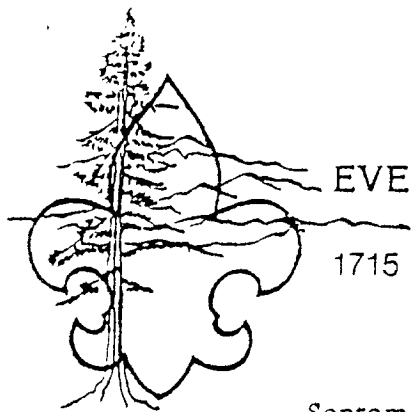

Dear Paul:

Enclosed are two separate pieces of information. The newspaper article relates to Charles S. Grewe, who has a registration denial file at the National Office beginning in March 1988. This is updated information.

The second enclosure is the letter and background information on the denial of registration of Richard Osher. I thought you had been given copies of the information in August when this action was taken by our Field Director, Bruce Spencer and Council President, Bob Overstreet. I was on vacation at the time.

Richard Osher had been serving as our Council Commissioner up to a month prior to when Bruce Spencer received a phone call from Terri Clark [REDACTED] at the Department of Social and Human Services (DSHS). She told him that Osher was being investigated for the molestation of [REDACTED] who is in her mid-teens.

[REDACTED] was supposedly molested as a young child by someone else and has been undergoing therapy for several years. While in therapy sessions these past months, she has repeatedly claimed that Osher had molested her. We have no verification that this charge has been proven true; however, DSHS asked him to inform us of this situation.

Spencer and Overstreet met personally with Richard and his wife [REDACTED] when they handed them the letter suspending his registration. The Oshers, knowing BSA standards and procedures, expected this action. They expressed the feeling that it had to be done.

At this time [REDACTED] and [REDACTED] feel he is innocent. They claim that he has taken a lie detector test which has proven that he did not molest [REDACTED]. [REDACTED] also feels Richard has been extremely supportive in trying to help [REDACTED] seek help through counseling over the years.



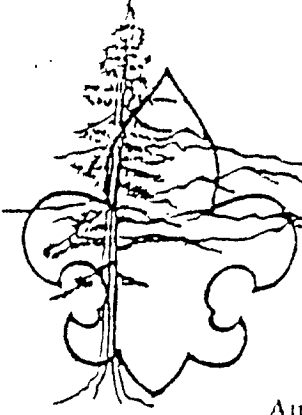

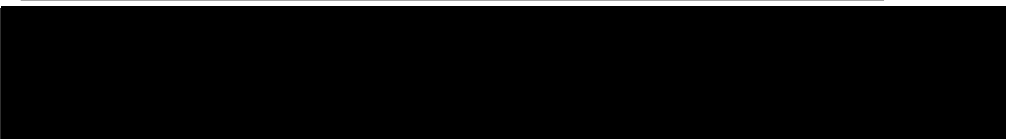
