Richard H. Felker, 48, of 210 Church St., Breesport, will be sentenced on August 18 after he pleaded guilty Monday to a charge of second-degree sodomy, the Chemung County District Attorney Office reported.

Felker was charged after he had sexual relations with a male under 14 years of age. He was also charged with having sexual relations with a female under 14 years of age, but that charge was dropped, according to the district attorney's records.
