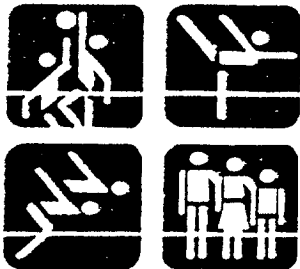


GENERAL DESCRIPTION: 38 yrs old, medium build, 5'11",

Larry resigned his position at the Whitin Community Center on March 23, 1989, at my request.

The previous day I had been officially informed of an ongoing police investigation against Larry, stemming from a complaint filed by the parents of a 14-year-old boy. The parents eventually decided not to press charges. Larry admitted to sexual offenses concerning this 14-year-old. My briefing was by Northbridge Chief of Police Thomas J. Melia III.

Larry also admitted to me that the allegations were true.
