Dear Mr. Holmes,

On June 3, 1989 one of my Scoutmasters, Bob Myers, was soliciting funds for a boy to go to National Jamboree. One of the people that he talked to refused to give any money due to the fact that Mr. Holland was active in the program and the man said, " He would not give any support to a youth program that allowed homosexuals to be leaders. "Upon hearing this Bob made a report to me as instructed in the Youth Protection Plan.

Later after discussing the situation with several Scout leaders there arose an incident that Mr. Holland was involved with in the past which led to his resignation from the troop. Apparently there were some homosexual activities in the troop by which he was an assistant Scoutmaster. There were no charges filed.

However this conversation led me to Deputy Sheriff P. J. Duke in which he said that "Ricky Holland is a known homosexual and that charges were brought of child molestation in Selma City Court these charges were absterged but he still was a known homosexual and in his opinion. Under no circumstances should Mr. Holland be allowed contact with children." This letter summarizes the events which led to Mr. Holland's dismissal from the program.
