

Area man sentenced in sexual abuse case

Robert A. Schindler, 43, of 4912-A Wilmot Road, Sunnyside, McHenry, was sentenced Tuesday to serve a three-year term of imprisonment after conviction on a sex abuse charge.

Schindler was charged Sept. 1, 1985, with aggravated criminal sexual assault, to which he pleaded not guilty.

However, in a negotiated plea, the charge was amended Tuesday from aggravated criminal sexual assault to aggravated criminal sexual abuse, and Schindler withdrew his not guilty plea and pleaded guilty to the amended charge.

The sex abuse charge against the defendant is alleged to have involved a boy under 13 years old.

According to testimony before Judge Michael Sullivan on Tuesday in 19th Judicial Circuit Court, Schindler had a previous sex offense conviction.

Defense counsel Evan Lewis, who negotiated the plea with the state, explained to the court that Schindler suffered from serious medical problems.

The defendant had been free on \$50,000 bond since shortly after his arrest.

He was taken into custody by sheriff's police Tuesday, awaiting transportation to the Illinois Department of Corrections.

In other court action, Thomas A. Murawski, 20, of 1265 Sterling, Palatine, was arraigned Tuesday on a charge of aggravated criminal sexual assault.

The complaint against Murawski alleges that the defendant knowingly committed an act of sexual penetration with a girl under 13 years old.

He was arrested in early January and waived a preliminary hearing on Feb. 6.

On Tuesday, Murawski appeared before Judge Roland Herrmann in 19th Judicial Circuit Court, where he pleaded not guilty to the charge. The court set trial for April 7.

Conviction on the offense of aggravated criminal sexual assault brings a sentence of between six and 30 years.

McHenry man charged with sexually assaulting youths

WOODSTOCK — A McHenry man was released on \$5,100 bond Tuesday night from McHenry County Jail where he had been held on \$51,000 bond on criminal sexual assault charges.

Robert A. Schindler, 43, of 4912-A Wilmot Road, McHenry, appeared before Judge Haskell Pitluck for a night's hearing Saturday on charges

of aggravated criminal assault and criminal sexual abuse.

Sheriff Hank Nulle said this morning that Schindler had been under sheriff's police investigation for some time.

According to Undersheriff George Hendle, two youths, members of the Northern Youth Outdoor Club, reported to sheriff's police that Schindler had sexually molested them in 1984.

During subsequent investigation,

Hendle said five additional male youths have reported being sexually fondled by Schindler.

Hendle said three of the boys reported the incidents occurred outside of McHenry County while on camping trips with Schindler.

Sheriff's police are conducting an ongoing investigation to determine if there are any additional offenses involving children, Hendle said today.

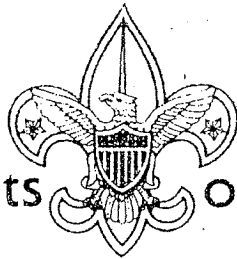

Dear Mr. Lewis:

In response to your letter of October 10, 1984, I am hereby requesting an immediate hearing to clear myself of the unwarranted charges currently pending against me. On Tuesday, October 16, I have an appointment, which I requested, with the States Attorney, Juvenile Officer and Jim Connerty to get this matter resolved.

In June of 1981, upon returning from Camp Lowden with my troop, I received a telephone call from Ray Smith, Camp Director, requesting that I serve as Medical Officer at Kishwaukee Reservation, Boy Scout Camp, Calumet Council. After reviewing my qualifications, Ed Black, Director of Support Services, BSA, Calumet Council, hired me, whereupon I was required to report to Kishwaukee Reservation the following day.

During the first week, I found it difficult to teach First Aid, CPR, and run the medical lodge by myself. After making arrangements with Ed Black to bring some of my scouts to camp to assist me, I contacted [redacted] to see if he would like to come for the following week. I left camp at 10 a.m. Saturday to go home. Mrs. [redacted] dropped [redacted] off at my house that afternoon. She stated that she was unable to get a physical for [redacted] on such short notice, so I should examine him as the Camp Medical Officer. I gave him a physical that day while my wife and son were at home. We left on Sunday morning to report to camp at 10 a.m.

I hope that this explanation will dispel any doubts you may have regarding my integrity as a scoutmaster. I was totally appalled that I could be suspended so casually without anyone hearing my side of the story. I have dedicated most of my life to the BSA, and I would never do anything to hurt one of my boys.

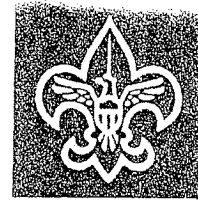

During a juvenile investigation by the McHenry County Sheriff's Police it was brought to my attention that a Mr. Robert A. Schindler had been accused of a illicit sexual contact with a minor male subject. The Sheriff's Deputy took the initial report on the evening of 21st. September 1984 and I was informed the morning of the 22nd.

Further investigation was made by the Sheriff's Police stating that this allegation occurred in the summer of 1981 in the bedroom of Mr. Robert A. Schindler's residence at 7408 Cunio Drive, Spring Grove, Illinois located in McHenry County.

During the course of the investigation, the Sheriff's Department's juvenile officer, Detective George Shirey and Robert Hrodey of the McHenry County State's Attorney's Office, were advised of the situation involving Mr. Robert Schindler.

Further investigation revealed that in the summer of 1981 after returning from an Order of the Arrow tap out at Camp Lowden, Oregon, Illinois, seven young scouts, approximately 11 to 12 years old stayed at Mr. Schindler's

Thank you very much for your recent letter concerning Robert Schindler. The whole situation is most unfortunate. While we are sympathetic to the point of view you have expressed that Mr. Schindler may not be completely alone in the guilt of recent incidents, and that it is possible considerable blame should be placed upon the boys themselves, we cannot ignore that Mr. Schindler as leader was the responsible adult in charge. If he in any way participated as the boy's letters, which you monitored, claim, then we cannot accept the responsibility of having Mr. Schindler continue in a leadership role in the Scouting program.

Possibly at some future time, after Mr. Schindler has developed greater maturity, and may possibly have the responsibility of raising a family of his own, and has established himself in a responsible citizenship role in his community, consideration might then be given to his application for his registration in the Boy Scouts of America.

Your present letter will be carefully considered at such a time, and we thank you for sending it to us.

This letter was delayed because of obtaining your address only recently and because of my duties just before Easter.

This letter is written in behalf of Mr. Robert Schindler, erstwhile Advisor of Explorer Post 109, Fraternal Order of Eagles Aerie 1344, Forest Park, Illinois.

You received written statements of some of the Explorers accusing Mr. Schindler of immoral personal action with them. I monitored the boys while they wrote the statements.

I have known Mr. Schindler since 1950. He attended our parish school through third grade. He was transferred to an Oak Park Public school, one reason being because of the specialized help which he required. Since he has left school, Mr. Schindler has worked a various jobs. My contact with Mr. Schindler has been on social basis and in his activities with the scouts. In 1962 Mr. Schindler was with the group which went to Philmont. In all the time I have known him nothing of this nature has ever come up. He is rough and ready; his language is not always the best. However, I do not know of any grounds for accusations of immorality.

While I realize that any connection with Post 109 is out of the question, I do not think that Mr. Schindler ought to be prohibited from all Scout participation.

The circumstances of the accusations, I believe, must be considered in making a final decision. Some of the boys involved were caught in the act of immorality on the last campout. Mr. Schindler did not discover them so acting. Parents were notified of the occurrence. Then followed the accusation of Mr. Schindler. If what the boys wrote is true, how much was provoked by themselves? If any one freely cooperated, that boy should also be expelled. For he is an asset to Scouting either.

I hope my statement is some help to you in this matter.

Park. On this route Mr. Schindler stopped the car
the road, turned around in the seat of the car and

I was only on one campout, but I'll write what I've seen.

It was a campout at Dan Beard, a few months ago, that I saw what Schindler does on some campouts. It was on a Sunday morning, a few hours before we left, when Schindler went to three or four different boy bunk to get them up. He did this by forcing his hands down to the boy's organs and squeezing them. I can only name two boys, [REDACTED] and [REDACTED], who I can remember distinctly to have gotten this treatment.

On the way home on the same day of that camping trip at [REDACTED] Schindler and myself were riding back in Schindler's car. On the way, Schindler pulled off to the side of the road and started to grab for our organs. He first turned to [REDACTED], then [REDACTED] and myself in that order. After having fun, he started up again.

I tried to get him away but he pinched harder. Also during my induction to the ~~post~~ he ~~sp~~ put eggs all over my sexual organs by rubbing it on with his hand. Before he did this he tied my hands behind my back. And while he did this he was laughing. Another time he grabbed me and started wrestling with me. I tried to get loose from him but he got me down and ~~with~~ threw his head with great force on my penis, this hurt a great deal. The event of the induction took place at Morris Illinois, and the wrestling event took place at camp Dan Beard. At ~~camp~~ Sullivan he made ~~me~~ take down his pants and run around outside.
