On Thursday, 03/15/90 8:45 A.M., I learned that a Robert Lemley, registered as a district member at large in the Chinook District of the Inland Northwest Council had been arrested for a charge of Child Molestation. I did understand from Steven Bates D.D.S, Stake President of the Spokane Stake LDS Church that his arrest was for molesting girls in his neighborhood. No Boy Scouting youth were involved to my knowledge.

I have subsequently written the appropriate letter to advise Robert that his registration was being suspended with the Boy Scouts of America. My dilemma is that I will not be able to deliver this letter, at least not easily. I have spoken with individuals at the Spokane Police Department. I understand that he has been convicted and now is in jail. This information did not come out in the news paper but, I will follow up with the Superior Court for any public information I can find.

Enclosed is a copy of the letter as well as the Confidential Record Sheet. If there is anything further I need to do, please advise.

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.
