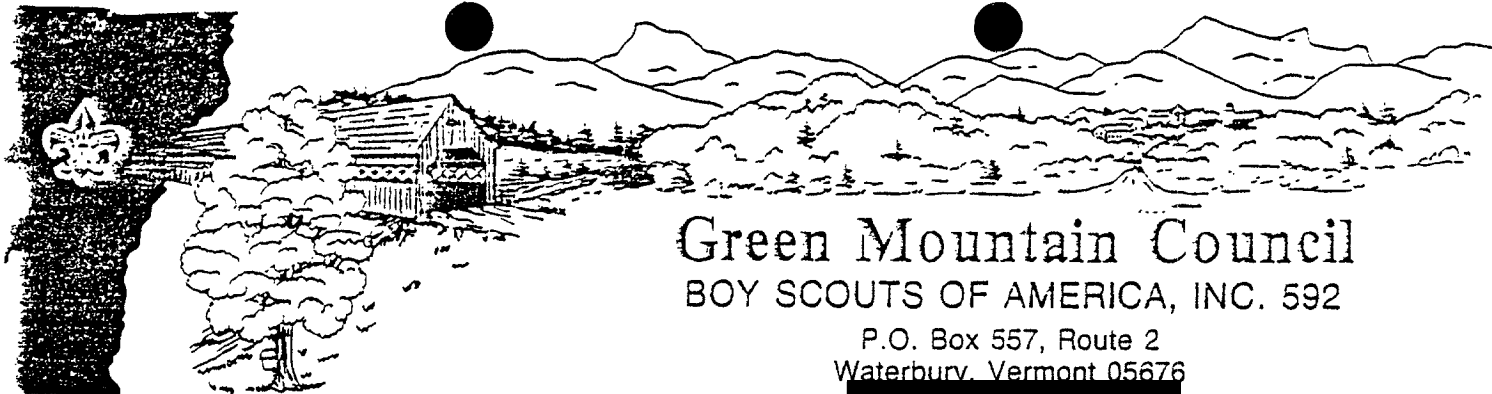

Do you have any other information which you can give us or any statements which would help to substantiate this charge? These items are necessary if we are to place Mr. Cochran on our file and refuse registration in any other location.

I am enclosing a Confidential Record Sheet which I would like to have completed if you have the necessary information. If you can give me substantiation of the charge by documented statement or a tape with [REDACTED] statement on it, we would then be able to secure the Confidential Record Sheet from the council in Arizona if you do not have all the pertinent information at this time.

We also have a question and wonder if this man ever goes by the name of Will Cochran. This was another individual whom we have had information about at an earlier time.
