Former Scout Leader Receives 2 Life Terms

-Bonita DelReal cried yesterday as she left Courtroom 5A at the Forsyth County Hall of Justice. where she saw her husband. Robert DeiReal Jr., sentenced to two life sentences and 49 years in jail for sexually abusing five young men, including her son.

She did not cry for DelReal. She cried for relief.

"I was very pleased with the way the trial went, the verdict and the sentence," she said. "It's something lifted from my shoulders, and I don't have to fear anymore.'

She testified during the trial that DelReal beat her and her son, Richard Anthony Snowden, over the 14 years that she and DeiReal were married. She said sne did not know that DeiReal sexually abused her son until last summer, after she learned that a nephew said he had been molested.

"I'm so proud of these boys,"

she said of the five young men who testified that DeiReal had molested them at times over more than seven years. "It took a lot of courage to do what they did.'

Karen DeiReal, DeiReal's sisterin-law, is the mother of two of the boys who testified that they were abused. After the sentencing, she hugged her children and the others involved in the case.

"I'm not a lawyer, so I don't understand it all," she said. "But if he's going to spend the rest of his life in jail, it's fine. But that won't fix what he has done to our boys.'

Snowden, 19, who said that his stepfather began abusing him when he was about four years old, said simply: "I'm just glad it's over. That's all."

DeiReal, a former Stroh Brewery employee and a Boy Scout leader at Kingswood United Methodist Church for more than 10 years, was

4 Youths **Testify** About Sex Abuse

Four young men testified yesterday in Forsyth Superior Court that they were sexually abused by a Forsyth County man charged with 21 counts of sexual crimes involving boys who were teen-agers or younger.

Robert DeiReal Jr., 41, of 6821. Old Highway 52 faces 13 life sentences and 200 years more in prison if he is convicted on all counts. He is charged with 13 counts of first-degree sexual offense, four counts of second-degree sexual offense, and two counts each of crime against nature and taking indecent liberties with a minor.

Three of the young men were relatives of DeiReal's, and one was a friend of his stepson. DelReal is also charged with abusing a fifth young man, who has not testified.

DelReal was a Scoutmaster for a Boy Scout troop during some of the time that the young men said the abuse happened. But his stepson was the only one who said he was abused during any Scout functions. Prosecutor Janet H. Branch said that DeiReal was a Scoutmaster at Kingswood United Methodist Church near Rural Hall.

Police began investigating Del-Real after the stepson told his mother in July that DelReal had sexually abused him for years.

The stepson, Richard Anthony Snowden, now 19, testified that he was about 4 years old when the abuse began.

Eleven of the charges filed against DelReal involve Snowden. The indicaments say that those 11, all first- and second-degree sexual offenses, happened from 1982 to 1988. But Snowden said that Del-Real abused him for years longer and that for weeks at a time it would happen as often as twice a

"Anytime, it seemed, my mom would leave or we'd be alone. I would have to get naked," he said.

DEFENSE actorney David F. Tamer attacked Snowden more strenuously than the others. Tamer said that Snowden's bad relationship with his stepfather led to the accusations against DelReal.

He questioned Snowden about his criminal record. He also asked Snowden about his repeated treatment for drug abuse and his membership - for about six-weeks in a Los Angeles gang called the Crips, which Snowden joined while he lived in California last summer.

The first young man to testify, a 12-year-old relative of DeiReal's. said that DelReal molested him as many as 10 times from August 1984 to August 1986. He said that DelReal forced him to commit anal and oral sex acts.

A 14-year-old relative of Del-Real's testified that he was abused twice in August 1986, though he could not remember the exact dates. The two indecent-liberties i charges allege that DelReal abused this young man.

Another young man, 17, who is not related to DelReal, testified that DelReal committed a sexual act with him last summer.
