On September 12, 1990 at twelve noon, I received a called from Howard Herlihy of Council 47, in Sacramento.

This caller referred to Mr. Halferty and the fact that he is on our Ineligible Volunteer File. Apparently, no legal action has transpired against Mr. Halferty, but he was refused registration by the unit with which he was associated. They did not feel comfortable with him in their unit and in the association with their youth members.

We are maintaining a file and will refuse registration should it come to us, or at least tell the council we are doing so, and ask them to make a decision on whether they want him working with their unit, after giving them the facts that we have.

The investigation had no relationship to Scouting; however, we feel that this action is necessary. I have confirmed with the clerk of the Sheriff's office that there is such an investigation underway; however, they would not share any of the details with me. If, and when, I'm able to discover any additional factual information, I will forward it to you.

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.
