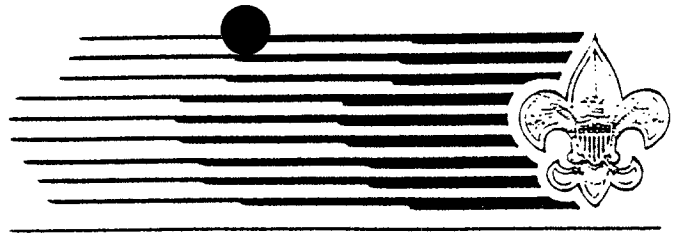

This office represents [REDACTED], a minor, who was a member of the Explorer Scouts Post Number 24 at the City of Irvine Police Department.

My client was sexually molested by an explorer scout leader by the name of Robert E. Kredel while participating in several scouting activities. The incidents referred to occurred in November, 1984, and the Spring of 1985.

It is my policy to offer all potential litigants the opportunity prior to commencing litigation to discuss an out-of-court settlement. For that reason, I am writing at this time to suggest that this matter be referred to your liability insurance carrier, or claims department, as the case may be.
