OPPORTUNITY TO DEMONSTRATE COMPLIANCE REPORT

[redacted] came in for an informal conference with Marilyn Mikel on January 18, 1991. They told Ms. Mikel that they could not afford the financial charges required for Mr. Swift's psychological evaluation.

Then on January 25, 1991, [redacted] informed this consultant that she had now decided to obtain the psychological evaluation for her husband. She was then informed in writing in a letter dated January 28, 1991, that we would have to receive this information about her husband by March 1, 1991. Otherwise, negative action would be recommended regarding her Certificate of Registration.

The deadline has passed and this Department still has not received Mr. Swift's psychological evaluation. Therefore, the noncompliance cited with Rule 2 (6) suitability and good moral character in the previous report will continue to be cited.

Based on the findings of this investigation, it is the Department's determination that [redacted] is in willful and substantial violation of Rule 2 (6) suitability and good moral character of the day care home family.

I recommend that the Department revoke [redacted] Certificate of Registration.

I have reviewed the Registration Study Report regarding the Family Day Care Home registration referenced above. Based upon the findings and the evidence summarized in the attached report, it is my decision to provide you with notice of intent to revoke your Certificate of Registration to operate a Family Day Care Home.

This action is being taken as a result of the following area of noncompliance:

Administrative Rule R1802(6) - *"the day care home family shall be of good moral character and be suitable to assure the welfare of children."*

On the basis of these findings, I conclude that they represent willful and substantial violation of the Administrative Rule identified above.

Attached is a copy of the Registration Study Report summarizing the findings resulting from the investigation.

In accordance with Section 11(2) of Act No. 116, Public Acts of 1973, as amended, please be advised that you may appeal this decision in writing within 30 days of receipt of this letter. If you elect to appeal this decision, please forward your written request to:

I received a phone call from [REDACTED] a concerned parent living in Dansville, Michigan related to Robert Swift about whom she had concerns. She expressed and shared information that she was aware he was an individual that had been convicted back in 1981 in Alpena, Michigan of molesting a 15 year old boy while a member of the Big Brother program. She shared at that time that there had been a conviction with probation for Robert E. Swift. She also shared with me that I could get some possible information from a Brian Bumgardner who was a social worker in the Mason area investigating a case related to his wife's (Swift's) application to a day care center. All this conversation occurred on December 14, 1990 with [REDACTED].

After that conversation I followed up with Brian Bumgardner a few days later, he stated on December 19, 1990 the investigation was in progress and he did not have any information to share with me at that time related to the Swift application for day care. Later contacted [REDACTED] again in early February on the 5th and discussed with her that I had the conversation with Brian Bumgardner and had not heard any further information from him. She stated that she could give me the name of the social worker from the Department of Social Services in Alpena who had information about the court case that Robert E. Swift was convicted in with probation.



I received a phone call the same day from Kathy Gutierrez Department of Social Services in Alpena office giving me information related to Robert E. Swift and his conviction. She gave me information related to the prosecuting attorney and his phone number. The following day February 6, 1991 I called the prosecuting attorney's office in Alpena talked with his secretary Susan who listened to my information that I had available on Robert E. Swift. She indicated that the information was correct but could not release any information without the prosecuting attorney's approval. She said she would get back to me. Fifteen minutes later the prosecuting attorney named Dennis Grenkowitz called me back stating that indeed Robert E. Swift had been convicted of a charge of sexual contact with a 15 year old boy. This conviction occurred in November of 1981 in the Alpena area. He basically was convicted and pled guilty to gross indecency with a minor. The sentence as agreed upon by the prosecuting attorney was one year probation with one year counseling with a counselor on sexual deviate behavior. The record was then wiped clean as per agreement after Robert E. Swift served his probation. The prosecuting attorney did state to me that in his judgement from looking at the file of Robert E. Swift that he absolutely should not be involved in Scouting in any manner.

After this conversation, the following day on February 7, 1991, I called and talked to Paul Ernst at the National Office and shared this information with him. He indicated that since Robert E. Swift was registered as a Tiger Cub parent with his son and not registered formally in the Cub Scout Pack with the National Boy Scouts that no action at this time would be necessary in the form of a letter to Robert E. Swift from the Boy Scouts. However, he requested that I put together all the background information I had on Robert E. Swift with documentation and send it to the National Office to his attention so that a file could be created on Robert E. Swift, the purpose of which being that if he should attempt to register formally with the Boy Scouts in the future the record would be available. At that time action would be taken to inform him that he could not register with the Boy Scouts of America. That information has been assembled and will be mailed to Paul Ernst today February 12, 1991.
