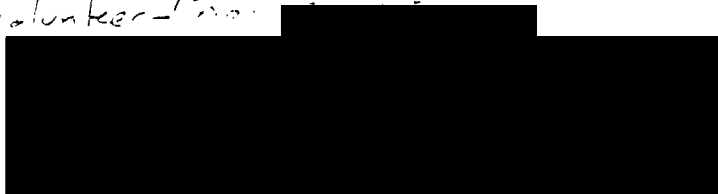

Photos of nude girl, 10, lead to S.J. man's arrest

A 63-year-old San Jose man picked up his processed film at a photo store, where police officers were waiting for Robert Graham Ney because photo clerks, curious about the man who kept asking when his film would be ready, looked at the finished pictures to see why he wanted them so much.

The clerks called police after seeing the photos of a nude little girl, detectives said.

Ney, who police say had given the store a false name and phone number when he dropped off the film, originally was arrested last Saturday on suspicion of misdemeanor possession of child pornography because the victim was unknown, police

said. He was soon out on bail, police added.

He was rearrested Friday on a \$50,000 felony warrant issued by the district attorney's office after police found and interviewed the girl in the pictures, a 10-year-old relative who doesn't live with Ney.

The child, according to detectives, said she had been molested numerous times by Ney since 1988 at her home as well as at Ney's.

Detectives learned the child also had been photographed in similar poses last year. Other girls in the family denied they had been molested, officers said.

The warrant charges Ney with child molesting and exploitation, lewd and lascivious acts against children, and persuading a minor to pose for obscene photos.
