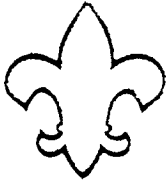

Based on a passing comment by an unidentified source, we have investigated to the best of our ability an alleged sexual incident involving a non-Scout (male) that has resulted in the following:

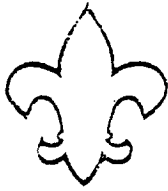
1. Police Officer Robert Kevin Corbley resigned from the Gladstone Police Public Safety Department;

Dear Mr. Corbley:

After careful review, we have decided that your registration with the Boy Scouts of America should not be accepted. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.
